5	The General Assembly of the Commonwealth of Pennsylvania
6	hereby enacts as follows:
7	Section 1. Section 1105(b)(5) and (c) of Title 65 of the
8	Pennsylvania Consolidated Statutes are amended to read:
9	§ 1105. Statement of financial interests.

11	(b) Required informationThe statement shall include the
12	following information for the prior calendar year with regard to
13	the person required to file the statement:
14	* * *
15	(5) The following shall apply:
16	<u>(i)</u> The [name and address] <u>amount and source</u> of any
17	direct or indirect source of income totaling in the
18	aggregate \$1,300 or more. [However, this] <u>The source</u>

1	shall be identified by its name and address.
2	(ii) The amount of the income shall be reported by
3	indicating one of the following ranges for the amount:
4	(A) between \$1,000 and \$74,999;
5	(B) between \$75,000 and \$99,999;
6	(C) between \$100,000 and \$149,999;
7	(D) between \$150,000 and \$249,999;
8	(E) between \$250,000 and \$499,999;
9	(F) between \$500,000 and \$749,999;
10	(G) between \$750,000 and \$999,999; or
11	<u>(H) \$1,000,000 or more.</u>
12	(iii) Income received in the form of a security may
13	be reported by indicating the number of shares and the
14	name and address of the issuer. For purposes of this
15	paragraph, "security" shall have the same meaning given
16	to it in 13 Pa.C.S. § 8102 (relating to definitions).
17	(iv) This provision shall not be construed to
18	require the divulgence of confidential information
19	protected by statute or existing professional codes of
20	ethics or common law privileges.

22	(c) Reporting amountsExcept where an amount is required
23	to be reported pursuant to subsection [(b)(6)] (b)(5), (6) and
24	(7), the statement of financial interests need not include
25	specific amounts for the items required to be listed.

27	Section 2. This act shall take effect January 1, 2019.
