AN ACT

Section 1702(b) of Title 51 of the Pennsylvania Consolidated Statutes is amended to read: 8 9 § 1702. State Veterans' Commission. * * * 10 (b) Composition. -- The commission shall be composed of: 11 12 The Adjutant General, ex officio, or his designee. (1)13 The State commander, commandant or head, or his 14 designee, of each of the following named veterans' 15 organizations: 16 The American Legion. (i) 17 (ii) AMVETS.

(xviii) The Navy Club of the United States of 17 18 America. 19 (3) Four members at large appointed by the Governor from 20 a list provided by the Adjutant General, each of whom shall 21 be a veteran and a member in good and regular standing of a 22 Pennsylvania branch, post, lodge or club of a recognized national veterans' organization active in this Commonwealth. 23 24 At least one member shall be a female veteran, and at least one member shall be a veteran of the Vietnam era. Members at 25 26 large shall serve a term of four years and until a successor 27 has been appointed. 28 The State Adjutants of the American Legion, the 29 Disabled American Veterans (DAV) and the Veterans of Foreign
