- 9 SECTION 1. SECTION 1402(D)(1), (4)(II) AND (III) AND (6) OF <--

- 11 AND THE SUBSECTION IS AMENDED BY ADDING A PARAGRAPH TO READ:

- 14 (d) Contracts or purchases. -- The contracts or purchases made
- 15 by council, which shall not require advertising, bidding or
- 16 price quotations as provided in this part, are as follows:
- 17 (1) Those for <u>emergencies or for</u> maintenance, repairs or

1 replacements for water, electricity or public works of the 2 borough, if they do not constitute new additions, extensions 3 or enlargements of existing facilities and equipment, but security may be required by council, as in other cases of 4 5 work done. For those contracts or purchases made in cases of 6 emergencies, the actual emergency and the nature of the 7 procurement shall be stated in a resolution by council and adopted at the next public meeting. 8 * * * 9 10 (4) * * * <--(II) THOSE MADE FOR UTILITY SERVICE FOR BOROUGH 11 12 PURPOSES, INCLUDING, BUT NOT LIMITED TO, THOSE MADE FOR 13 NATURAL GAS OR TELECOMMUNICATIONS SERVICES AND 14 ELECTRICITY.
