## AN ACT

- Amending the act of June 27, 2006 (1st Sp.Sess., P.L.1873, 1 No.1), entitled "An act providing for taxation by school districts, for the State funds formula, for tax relief in 3 first class cities, for school district choice and voter participation, for other school district options and for a 5 task force on school cost reduction; making an appropriation; 6 prohibiting prior authorized taxation; providing for 7 installment payment of taxes; restricting the power of 8 certain school districts to levy, assess and collect taxes; 9 and making related repeals," in senior citizens property tax and rent rebate assistance, further providing for 10 11 definitions. 12 13 The General Assembly of the Commonwealth of Pennsylvania 14 hereby enacts as follows: 15 Section 1. The definition of "income" in section 1303 of the act of June 27, 2006 (1st Sp.Sess., P.L.1873, No.1), known as 16 17 the Taxpayer Relief Act, amended November 2, 2016 (P.L.969, No.17), is amended and the section is amended by adding a 18 19 definition to read: 20 Section 1303. - 3 "Income." All income from whatever source derived,
- 4 including, but not limited to:
- 5 (1) Salaries, wages, bonuses, commissions, income from
- 6 self-employment, alimony, support money, cash public
- 7 assistance and relief.
- 8 (2) The gross amount of any pensions or annuities,
- 9 including [railroad]:
- 10 <u>(i) Railroad</u> retirement benefits for calendar years
- 11 prior to 1999 and 50% of railroad retirement benefits for
- 12 calendar years 1999 and thereafter.
- (ii) Social Security substitute pensions for
- calendar years prior to 2015 and 50% of Social Security
- substitute pensions for calendar years 2015 and
- thereafter.
- 17 (3) (i) All benefits received under the Social Security
- 18 Act (49 Stat. 620, 42 U.S.C. § 301 et seq.), except
- 19 Medicare benefits, for calendar years prior to 1999, and
- 20 50% of all benefits received under the Social Security
- 21 Act, except Medicare benefits, for calendar years 1999
- and thereafter.

- to the contrary, persons who, as of December 31, 2012,
- are eligible for the property tax or rent rebate shall

- 24 Security Act. The amount of the pension that qualifies as a
- 25 <u>"Social Security substitute pension" shall not exceed the</u>
- 26 maximum Federal old age and survivor benefit payments, less any
- 27 Federal old age and survivor benefit payments received under the
- 28 Social Security Act for employment covered under the Social
- 29 Security Act.

1 Section 2. This act shall take effect immediately.
