## A RESOLUTION

- 1 Urging the President and Congress of the United States to
- continue their commendable efforts to reduce Federal
- 3 regulatory burdens.
- 4 WHEREAS, The Constitution of the United States requires a
- 5 proper separation of powers between the three branches of
- 6 government, with lawmaking that is accountable to the people;
- 7 and
- 8 WHEREAS, Rulemakings by Federal agencies have overtaken
- 9 Congressional action as the primary vehicle for setting national
- 10 policy affecting State and local governments, business and
- 11 families; and
- 12 WHEREAS, At the end of 2016, the Federal Register, the
- 13 official depository of record of final and proposed rulemakings,
- 14 totaled 95,894 pages, nearly 20% more pages than at the end of
- 15 2015; and
- 16 WHEREAS, The cumulative number of Federal regulatory
- 17 rulemakings with estimated costs greater than \$1 billion

- 1 increased dramatically over the past 10 years; and
- 2 WHEREAS, Research conducted by the Mercatus Center at George
- 3 Mason University found that economic growth in the United States
- 4 has, on average, been slowed by 0.8% per year since 1980, owing
- 5 to the cumulative effects of Federal regulation; and
- 6 WHEREAS, The Constitution of Pennsylvania establishes the
- 7 General Assembly as the lawmaking branch of government of the
- 8 Commonwealth; and
- 9 WHEREAS, Research conducted by the Mercatus Center indicates
- 10 that Pennsylvanians are subject to more than 153,000 regulatory
- 11 restrictions; and
- 12 WHEREAS, In this Commonwealth, residents and businesses have
- 13 identified Federal and State regulatory burdens as a hindrance
- 14 to business development and the exercise of personal freedoms;
- 15 and
- 16 WHEREAS, Businesses have incorporated part of the cost of
- 17 compliance with Federal and State regulations into the price of
- 18 their products and services, thereby raising costs for families
- 19 and consumers; and
- 20 WHEREAS, The Pennsylvania House of Representatives State
- 21 Government Committee held hearings in 2017 to explore
- 22 Pennsylvania's regulatory environment in the context of burdens,
- 23 abuses, legislative oversight and potential solutions; and
- 24 WHEREAS, The State Government Committee found that regulatory
- 25 restrictions create a hurdle that businesses of all shapes and
- 26 sizes must jump over in order to create jobs in Pennsylvania;
- 27 and
- 28 WHEREAS, The State Government Committee also found that the
- 29 Regulatory Review Act does not currently give the General
- 30 Assembly the authority to stop the promulgation of a regulation

- 1 without the Governor's approval; and
- 2 WHEREAS, The hearings also revealed that the inconsistent
- 3 interpretation of regulations across the regions of this
- 4 Commonwealth is harmful to industries operating in this
- 5 Commonwealth; and
- 6 WHEREAS, The State Government Committee is recommending
- 7 legislative reforms and advocating for best practices that
- 8 committees can use to enhance their oversight role in regard to
- 9 regulations; and
- 10 WHEREAS, The recommended reforms are aimed at improving the
- 11 regulatory culture to ensure that the application of existing
- 12 laws and regulations is collaborative and not punitive, to
- 13 systematically review existing regulations and to stop faulty
- 14 regulations before implementation; and
- WHEREAS, Advocates of reform believe that a collaborative
- 16 approach to regulatory implementation and enforcement would best
- 17 ensure compliance and protection of public health and safety,
- 18 while removing barriers to job creation; and
- 19 WHEREAS, There is support among members of the House of
- 20 Representatives for regulatory reforms at the Federal and State
- 21 levels; and
- 22 WHEREAS, The Federal Administrative Procedure Act, the
- 23 governing legislation guiding the Federal rulemaking process,
- 24 has not been updated in 70 years; and
- 25 WHEREAS, The President of the United States has made a strong
- 26 commitment to regulatory reform by signing an executive order
- 27 requiring that two regulations be cut for each new regulation
- 28 proposed; and
- 29 WHEREAS, The President and Congress of the United States have
- 30 also utilized the Congressional Review Act to eliminate more

- 1 than 12 burdensome Federal regulations; and
- 2 WHEREAS, Congress has demonstrated an interest in improving
- 3 its regulatory oversight tools and processes in recent months
- 4 and has considered a number of regulatory reform initiatives;
- 5 therefore be it
- 6 RESOLVED, That the House of Representatives of the
- 7 Commonwealth of Pennsylvania urge the President and Congress of
- 8 the United States to continue their commendable efforts to
- 9 reduce regulatory burdens and thereby spur job creation and
- 10 economic growth; and be it further
- 11 RESOLVED, That the House of Representatives of the
- 12 Commonwealth of Pennsylvania recommend that Congress reaffirm
- 13 its role as the primary policymaking branch of the Federal
- 14 Government; and be it further
- 15 RESOLVED, That the House of Representatives of the
- 16 Commonwealth of Pennsylvania support efforts to restore
- 17 transparency and accountability to the Federal rulemaking
- 18 process; and be it further
- 19 RESOLVED, That copies of this resolution be transmitted to
- 20 the presiding officers of each house of Congress and to each
- 21 member of Congress from Pennsylvania.
