## A CONCURRENT RESOLUTION

Petitioning the Congress of the United States to call a 1 convention of states limited to proposing amendments to the 2 Constitution of the United States that impose fiscal 3 restraints on the Federal Government, limit the power and 4 jurisdiction of the Federal Government and limit the terms of 5 office for its officials and for members of Congress. 6 7 WHEREAS, The Founding Fathers, in drafting the Constitution of the United States, empowered state legislators to be 8 9 quardians of liberty against future abuses of power by the 10 Federal Government; and 11 WHEREAS, The Federal Government has created a crushing 12 national debt through improper and imprudent spending; and 13 WHEREAS, The Federal Government has invaded the legitimate 14 roles of the states through the manipulative process of Federal 15 mandates, most of which are unfunded to a great extent; and 16 WHEREAS, The Federal Government has ceased to operate under a 17 proper interpretation of the Constitution of the United States; 18 and

WHEREAS, It is the solemn duty of the states, in order to protect the liberty of the people of this nation, particularly for the generations to come, to propose amendments to the Constitution of the United States through a convention of states under Article V to place clear restraints on the abuses of power described in this resolution and related abuses of power; therefore be it

8 RESOLVED (the Senate concurring), That the General Assembly of the Commonwealth of Pennsylvania petition, under the 9 10 provisions of Article V of the Constitution of the United 11 States, the Congress of the United States to call a convention of states limited to proposing amendments to the Constitution of 12 13 the United States that impose fiscal restraints on the Federal 14 Government, limit the power and jurisdiction of the Federal Government and limit the terms of office for its officials and 15 16 for members of Congress; and be it further

17 RESOLVED, That this resolution constitute a continuing 18 application in accordance with Article V of the Constitution of 19 the United States until at least two-thirds of the legislatures 20 of the several states have made application for a convention on 21 the same subject; and be it further

22 RESOLVED, That a certified copy of this resolution be 23 transmitted by the Secretary of the Commonwealth to the 24 President of the United States Senate, the Speaker of the United 25 States House of Representatives, each member of the Pennsylvania delegation to Congress and to the presiding officers of each 26 house of the state legislatures, requesting their cooperation in 27 28 applying for an amendments convention limited to the subject 29 matter contemplated by this application.
