A RESOLUTION

- Designating the month of May 2019 as "Mental Health Awareness Month" in Pennsylvania.
- 3 WHEREAS, Mental health is critical to the overall well-being
- 4 of individuals, families, communities and businesses; and
- 5 WHEREAS, Mental illnesses are biologically based brain
- 6 disorders that cannot be overcome through willpower and are not
- 7 related to an individual's character or intelligence; and
- 8 WHEREAS, Mental health issues can affect individuals of any
- 9 race, religion, economic status or age; and
- 10 WHEREAS, Mental illnesses usually strike individuals in the
- 11 prime of their lives, often during adolescence and young
- 12 adulthood; and
- 13 WHEREAS, Individuals with mental illness have the same needs

- 1 and are guaranteed the same rights as all Americans; and
- 2 WHEREAS, Individuals with mental illness experience
- 3 discrimination in education, employment and housing; and
- 4 WHEREAS, A lack of full and proper treatment for individuals
- 5 with mental illness costs public and private employers billions
- 6 of dollars annually through absenteeism, turnover and low
- 7 productivity; and
- 8 WHEREAS, In 2017, an estimated 9.4% of adolescents 12 to 17
- 9 years of age experienced a major depressive episode (MDE); and
- 10 WHEREAS, Individuals are classified as having an MDE if they
- 11 experience a depressed mood or loss of interest in daily
- 12 activities and have additional symptoms, including problems with
- 13 sleep, eating, energy, concentration or self-worth over a
- 14 certain period of time; and
- 15 WHEREAS, In 2017, an estimated 44.6 million adults in the
- 16 United States had a mental illness that included a mental,
- 17 behavioral or emotional disorder; and
- 18 WHEREAS, Proper identification and treatment of mental
- 19 illnesses, including support, are proven to be effective and are
- 20 vitally important to assist individuals in leading full,
- 21 productive lives; therefore be it
- 22 RESOLVED, That the House of Representatives designate the
- 23 month of May 2019 as "Mental Health Awareness Month" in
- 24 Pennsylvania; and be it further
- 25 RESOLVED, That all government agencies, public and private
- 26 institutions, businesses, schools and residents of this
- 27 Commonwealth strive to increase awareness and understanding of
- 28 mental illnesses and the need for appropriate and accessible
- 29 services for individuals with mental illness throughout the
- 30 communities of this Commonwealth.
