A RESOLUTION

- Amending Rule 15 of the 2023-2024 General Operating Rules of the House of Representatives, further providing for time of
- 3 meeting.
- WHEREAS, On October 4, 2023, the Appropriations Committee of
- 5 the House of Representatives met after 11 P.M. and voted on
- 6 A02452 to Senate Bill 224 (Printer's Number 1159) and a motion
- 7 to report the bill from the committee as amended; and
- 8 WHEREAS, Republican members of the Appropriations Committee
- 9 received the text of the amendment at the meeting on October 4,
- 10 2023, and were given minutes to review the amendment before
- 11 having to vote on the proposal; and
- 12 WHEREAS, A portion of Rule 15 of the 2023-2024 General
- 13 Operating Rules of the House of Representatives states that "No
- 14 session of the House may begin before 8:00 A.M. nor may any roll
- 15 call votes be taken after 11:00 P.M. unless exigent
- 16 circumstances exist, as determined by an affirmative vote of
- 17 three-fourths of the members elected to the House, by a roll

- 1 call vote on a motion to extend session."; and
- 2 WHEREAS, On October 5, 2023, the House of Representatives
- 3 voted on a motion to object to the October 4, 2023, committee
- 4 report of the Appropriations Committee, with all Republican
- 5 members voting to object to the committee report; therefore be
- 6 it
- 7 RESOLVED, That Rule 15 of the 2023-2024 General Operating
- 8 Rules of the House of Representatives be amended to read:
- 9 RULE 15
- 10 TIME OF MEETING
- 11 The House shall convene on the first legislative day of the
- 12 week at 12:00 noon prevailing time, unless otherwise ordered by
- 13 a roll call vote of the majority of those elected to the House.
- On other days the House shall convene at the discretion of
- 15 the House. No session of the House may begin before 8:00 A.M.
- 16 nor may any roll call votes or votes in a committee or
- 17 subcommittee be taken after 11:00 P.M. unless exigent
- 18 circumstances exist, as determined by an affirmative vote of
- 19 three-fourths of the members elected to the House, by a roll
- 20 call vote on a motion to extend session. A motion to extend
- 21 session may be made to extend session generally or to conclude
- 22 business on a specific question or questions. If a motion to
- 23 extend session is made prior to 10:15 P.M. and a roll call vote
- 24 has not been ordered, the arrival of 10:45 P.M. shall put an end
- 25 to all debate and shall bring the House to an immediate roll
- 26 call vote on the question to extend session. Nothing in this
- 27 rule shall prevent the House from conducting administrative
- 28 matters, including the making of announcements regarding the
- 29 House schedule for the benefit of members or in order to comply
- 30 with 65 Pa.C.S. § 709 (relating to public notice) after 11:00

- 1 P.M. Upon the Speaker's determination that all administrative
- 2 matters are concluded, the Speaker shall adjourn the House.
