## A RESOLUTION

- Designating the month of October 2013 as "Archives Month" in Pennsylvania.
- 3 WHEREAS, The historical documents and records of our nation
- 4 and our Commonwealth provide a crucial link to our past; and
- 5 WHEREAS, We observe the 150th anniversary of the Civil War
- 6 and Pennsylvania's political role in the reconstruction of the
- 7 Union and its soldiers' military role at the Battle of
- 8 Gettysburg, recognized as the turning point in the war; and
- 9 WHEREAS, The earliest commemoration of the battle with
- 10 President Lincoln's Gettysburg Address became one of the most
- 11 important speeches in American history, placing Pennsylvania's
- 12 history at the center of national remembrance of the Civil War;
- 13 and
- 14 WHEREAS, The importance of the Commonwealth's history is
- 15 indispensable in moving forward to ensure that its citizens

- 1 remember its founding principles as stated by William Penn in
- 2 the Commonwealth's Frame of Government from May 5, 1682, that
- 3 "Any government is free to the people under it...where the laws
- 4 rule, and the people are a party to those laws"; and
- 5 WHEREAS, Appreciating this heritage and its lessons provides
- 6 immeasurable guidance for our future; and
- 7 WHEREAS, The House of Representatives has an established
- 8 archival repository for the records of elected members,
- 9 committees and administrative agencies of that body; and
- 10 WHEREAS, These historical records and documents, if not
- 11 professionally collected, cataloged and preserved by dedicated
- 12 archivists and staff and housed in a secure location, would be
- 13 lost to future generations of our citizens; therefore be it
- 14 RESOLVED, That the House of Representatives recognize the
- 15 invaluable contribution of its archival repository and its
- 16 committed staff members; and be it further
- 17 RESOLVED, That the House of Representatives designate the
- 18 month of October 2013 as "Archives Month" in Pennsylvania; and
- 19 be it further
- 20 RESOLVED, That the House of Representatives urge all
- 21 Pennsylvanians to visit their local archives, historical
- 22 repositories and libraries to learn more about the contributions
- 23 of historical documents and records to the discovery of the rich
- 24 heritage of this Commonwealth.
