- 11 WHEREAS, Professional counseling can assist individuals in
- 12 need of support for anxiety disorders, depression, grief and
- 13 loss, self-care, trauma, suicide prevention, substance use
- 14 disorders, relationship issues, career choices and life
- 15 transitions; and
- 16 WHEREAS, Professional counseling contributes to the growth
- and development of people across their life span and assists 17

- 1 them in achieving their full human, educational and career
- 2 potential; and
- 3 WHEREAS, Individuals can utilize professional counseling in
- 4 schools, colleges, mental health agencies, community agencies,
- 5 hospitals, rehabilitation centers, private practice and other
- 6 delivery settings; and
- 7 WHEREAS, More than 665,000 counselors are working across the
- 8 United States as vital members of the cadre of professional
- 9 human services providers alongside psychologists, psychiatrists,
- 10 social workers and other licensed professionals; and
- 11 WHEREAS, Professional counselors have a master's or doctoral
- 12 degree in counseling and are passionate, represent culturally
- 13 diverse communities and are committed to helping people from all
- 14 walks of life; and
- 15 WHEREAS, The American Counseling Association was established
- 16 in 1952 and is the largest organization of professional
- 17 counselors in the world; and
- 18 WHEREAS, The American Counseling Association offers an array
- 19 of programs and services to promote the professional development
- 20 of counselors and advocate for the counseling profession; and
- 21 WHEREAS, Since 2002, the American Counseling Association has
- 22 annually recognized April as "Counseling Awareness Month" to
- 23 advocate for the profession and as a celebration of the field's
- 24 accomplishments; and
