## A RESOLUTION

1 2 3 4 5	Urging the Congress of the United States to facilitate payment to insurance companies through Federal stimulus funds for the reimbursement of costs associated with the payment of claims made on business interruption insurance policies during the COVID-19 pandemic.
6	WHEREAS, Due to the current COVID-19 pandemic affecting the
7	United States, businesses face unprecedented financial
8	challenges, uncertainty and possible closure; and
9	WHEREAS, Congress is moving to provide financial assistance
10	to businesses affected by the COVID-19 pandemic in the form of
11	Federal stimulus funds; and
12	WHEREAS, Insurance companies are best suited to target and
13	identify those businesses with business interruption insurance
14	in place and to administer claim payments; and
15	WHEREAS, Businesses with existing business interruption
16	insurance have a vehicle in place for receiving reimbursement
17	and aid during these challenging times through the payment of
18	related claims by insurance companies; and

1 WHEREAS, Congress should pass legislation that channels 2 reimbursement and aid through insurance companies and provides 3 reimbursement to insurance companies that voluntarily pay claims 4 submitted on business interruption insurance policies; and

5 WHEREAS, The House of Representatives of the Commonwealth of Pennsylvania strongly acknowledges that all businesses are 6 7 deserving of Federal stimulus aid during these extraordinary 8 times and urges the inclusion of appropriate measures in the Federal aid package to assist all businesses as promptly as 9 10 possible, while recognizing that the proposed business 11 interruption insurance model may be an appropriate template; 12 therefore be it

13 RESOLVED, That the House of Representatives of the 14 Commonwealth of Pennsylvania urge the Congress of the United 15 States, as part of an overall COVID-19 relief package, to 16 reimburse, via the disbursement of Federal stimulus funds, 17 insurance companies for the costs associated with the voluntary 18 payment of claims to businesses made through business 19 interruption insurance; and be it further

20 RESOLVED, That a copy of this resolution be transmitted to 21 the presiding officers of each house of Congress and to the 22 members of Congress from Pennsylvania.
