A RESOLUTION

- 1 Urging the Congress of the United States, the President of the
- United States and the Environmental Protection Agency to delay the requirements of the MS4 storm water management
- 4 program for a period of two years in response to the COVID-19
- 5 crisis.
- 6 WHEREAS, The Federal Water Pollution Control Act (62 Stat.
- 7 1155, 33 U.S.C. § 1251 et seq.) allows the Environmental
- 8 Protection Agency (EPA) to regulate water pollution through the
- 9 National Pollutant Discharge Elimination System by requiring
- 10 regulated municipalities and other entities to create storm
- 11 water management plans and obtain permits for discharges of
- 12 storm water from their municipal separate storm sewer systems
- $13 \quad (MS4s); and$
- 14 WHEREAS, In seeking to comply with this mandate from the EPA
- 15 as enforced by the Pennsylvania Department of Environmental
- 16 Protection, municipalities in this Commonwealth have
- 17 increasingly begun placing tremendous economic burdens on our
- 18 residents, businesses and property owners by imposing new or

- 1 increased fees on them; and
- 2 WHEREAS, Residents and businesses throughout this
- 3 Commonwealth are facing unprecedented challenges because of the
- 4 COVID-19 crisis; and
- 5 WHEREAS, Federal, State and local governments must take
- 6 action to relieve economic burdens on individuals and businesses
- 7 who are struggling during these trying times to facilitate our
- 8 country's economic recovery and ensure that our citizens can
- 9 keep as much of their money as possible for essential needs;
- 10 therefore be it
- 11 RESOLVED, That the House of Representatives of the
- 12 Commonwealth of Pennsylvania urge the Congress of the United
- 13 States, the President of the United States and the Environmental
- 14 Protection Agency to delay the requirements of the MS4 storm
- 15 water management program for a period of two years in response
- 16 to the COVID-19 crisis; and be it further
- 17 RESOLVED, That the House of Representatives of the
- 18 Commonwealth of Pennsylvania urge the Congress of the United
- 19 States to enact legislation delaying mandated compliance
- 20 deadlines for states and municipalities of the MS4 storm water
- 21 management program for a period of two years to facilitate
- 22 economic recovery from the COVID-19 crisis; and be it further
- 23 RESOLVED, That the House of Representatives of the
- 24 Commonwealth of Pennsylvania urge the President of the United
- 25 States and the Administrator of the Environmental Protection
- 26 Agency to extend compliance deadlines for states and
- 27 municipalities of the MS4 storm water management program for a
- 28 period of two years to facilitate economic recovery from the
- 29 COVID-19 crisis; and be it further
- 30 RESOLVED, That a copy of this resolution be transmitted to

- 1 the presiding officers of each house of Congress, each member of
- 2 the Pennsylvania Congressional Delegation, the Administrator of
- 3 the Environmental Protection Agency and the President of the
- 4 United States.
