## A RESOLUTION

1 2	Designating June 15, 2014, as "Elder Abuse Awareness Day" in Pennsylvania.
3	WHEREAS, Older Pennsylvanians should be recognized as a
4	valuable resource to this Commonwealth; and
5	WHEREAS, No one is immune to the threat of elder abuse; and
6	WHEREAS, It is an obligation of all citizens to protect the
7	health, safety and welfare of this Commonwealth's elder
8	citizens; and
9	WHEREAS, The Commonwealth received more than 18,500 reports
10	of elder abuse in 2013 and it is estimated that only one in five
11	cases of abuse is reported; and
12	WHEREAS, The Department of Aging has declared the theme of
13	this year's Elder Abuse Awareness Day as "One Person, One
14	Action, One State - United Against Elder Abuse"; and

1 WHEREAS, The act of November 6, 1987 (P.L.381, No.79), known 2 as the Older Adults Protective Services Act, requires that older 3 adults who lack the capacity to protect themselves shall have 4 access to and be provided with the services necessary to protect 5 their health, safety and welfare; and

6 WHEREAS, A partnership exists between the Department of 7 Aging, the Pennsylvania Association of Area Agencies on Aging, 8 Temple University's Institute on Protective Services, district 9 attorneys, county elder abuse task forces and State and local 10 law enforcement to investigate every allegation of elder abuse; 11 and

12 WHEREAS, It is necessary to increase awareness of the 13 incidents of elder abuse and to educate people about the methods 14 to report suspected cases of abuse; therefore be it 15 RESOLVED, That the House of Representatives designate June 16 15, 2014, as "Elder Abuse Awareness Day" in Pennsylvania and 17 strive to increase awareness every day about elder abuse and the 18 resources in place to prevent it from occurring.
