A RESOLUTION

- 1 Urging the Congress of the United States to include additional 2 funding for victims of domestic violence in the next COVID-19
- 3 related stimulus package.
- WHEREAS, As of April 7, 2020, 306.3 million Americans, or
- 5 94.5% of the population of the United States, have been affected
- 6 by some form of stay-at-home order to help decrease the spread
- 7 of COVID-19; and
- 8 WHEREAS, The various forms of stay-at-home orders include
- 9 approximately 54 million K-12 students who are no longer able to
- 10 attend school in person and millions of adults who are unable to
- 11 work; and
- 12 WHEREAS, While these measures are necessary to reduce the
- 13 impacts of the current pandemic, it has provided domestic
- 14 abusers additional opportunities to further isolate victims and
- 15 withhold financial resources or medical aid; and
- 16 WHEREAS, The National Domestic Violence Hotline has reported

- 1 an increase in the demand for victim service providers; and
- 2 WHEREAS, Rural areas around the United States and American
- 3 Indian and Alaskan Native communities are experiencing the same
- 4 uptick in individuals seeking shelter from domestic violence and
- 5 have further limited resources to address the issue; and
- 6 WHEREAS, In response, a bipartisan group of 33 United States
- 7 Senators have come together to call for additional spending on
- 8 domestic violence-related programs in the next COVID-19 stimulus
- 9 package; and
- 10 WHEREAS, Additional funding is vital to the successful
- 11 operation of programs funded by the Family Violence Prevention
- 12 and Services Act (FVPSA), the Centers for Disease Control and
- 13 Prevention (CDC) and the Child Abuse Prevention and Treatment
- 14 Act; and
- 15 WHEREAS, The protection of victims of domestic violence
- 16 should be a priority during the current pandemic; therefore be
- 17 it
- 18 RESOLVED, That the House of Representatives urge the Congress
- 19 of the United States to ensure additional spending to support
- 20 victims of domestic violence are made a priority in the next
- 21 COVID-19 relief bill; and be it further
- 22 RESOLVED, That copies of this resolution be transmitted to
- 23 the President of the United States, the presiding officers of
- 24 each chamber of Congress and each member of Congress from
- 25 Pennsylvania.
