## A RESOLUTION

- Recognizing the month of September 2016 as "Suicide Prevention Month" in Pennsylvania.
- 3 WHEREAS, Suicide is a major preventable cause of premature
- 4 death; and
- 5 WHEREAS, Coordinated suicide prevention is an achievable
- 6 global public health goal; and
- 7 WHEREAS, The House of Representatives notes the imperative of
- 8 raising awareness that suicide is preventable; and
- 9 WHEREAS, Nearly 3,000 people on average die by suicide daily,
- 10 according to the World Health Organization; and
- 11 WHEREAS, For every person who has died by suicide, 20 or more
- 12 persons have attempted to end their lives; and

- 1 WHEREAS, Reducing suicide rates requires a worldwide response
- 2 to known psychosocial, cultural and environmental risk factors;
- 3 and
- 4 WHEREAS, The House of Representatives affirms that we must
- 5 make every effort to improve education and awareness and
- 6 decrease stigmatization relating to suicide; therefore be it
- 7 RESOLVED, That the House of Representatives recognize the
- 8 month of September 2016 as "Suicide Prevention Month" in
- 9 Pennsylvania.
