A RESOLUTION

1 2	Designating the month of October 2020 as "Dyslexia Awareness Month" in Pennsylvania.
3	WHEREAS, Developmental reading disorder, or dyslexia, is a
4	language-based learning disability that occurs when there is a
5	problem in areas of the brain that help interpret language; and
6	WHEREAS, Dyslexia's symptoms include slow or inaccurate
7	reading, poor spelling, poor writing or mixing up similar words;
8	and
9	WHEREAS, Problems experienced by people with dyslexia may
10	include:
11	(1) confusing letters or having difficulty learning the
12	sounds that go with letters;
13	(2) having trouble learning how to speak, recognizing
14	words or determining the meaning of a simple sentence; and
15	(3) having trouble processing the sounds of language,

such as rhyming;

3 WHEREAS, Dyslexia can include disorganization of written and 4 spoken language or struggles in comprehending and concentrating 5 on longer reading assignments; and

6 WHEREAS, Dyslexia may also include difficulty in correctly 7 performing math operations, memorizing number facts or learning 8 a foreign language; and

9 WHEREAS, Dyslexia is a specific information processing 10 problem that does not interfere with one's ability to think or 11 understand complex ideas; and

12 WHEREAS, Dyslexia is not caused by a lack of desire to learn 13 and affects people of all backgrounds and intellectual levels, 14 with the majority of individuals being of normal intelligence 15 and many being above average in intelligence; and

16 WHEREAS, Students with dyslexia are likely to struggle with 17 many aspects of academic learning, are at a higher risk of 18 dropping out of school entirely and often go for years without 19 being properly diagnosed; and

20 WHEREAS, Aside from problems in school, an individual with 21 dyslexia can experience a loss of self-esteem and general 22 reading problems that may persist into adulthood, which can 23 affect the individual's job performance; and

24 WHEREAS, According to the International Dyslexia Association, 25 approximately 85% of students classified as having a primary 26 learning disability have difficulty in reading and language 27 processing; and

28 WHEREAS, The number of people having some symptoms of 29 dyslexia is much higher, perhaps as much as 15% to 20% of the 30 entire United States population; and

1 WHEREAS, There is much hope for students who are correctly diagnosed with this disorder, as they can successfully learn 2 3 with appropriate teaching methods; and 4 WHEREAS, The earlier that dyslexia is diagnosed, the better 5 for the student; and 6 WHEREAS, Dyslexia is a disorder that often manifests among 7 members of the same family; and 8 WHEREAS, While dyslexia affects individuals throughout their 9 lives, its impact can change at different stages of life; and 10 WHEREAS, Dyslexia is an often misunderstood language-based disability, and a large percentage of residents of this 11 Commonwealth experience one or more symptoms of this disorder; 12 13 therefore be it 14 RESOLVED, That the House of Representatives designate the month of October 2020 as "Dyslexia Awareness Month" in 15

16 Pennsylvania.
