AN ACT

Amending Title 35 (Health and Safety) of the Pennsylvania Consolidated Statutes, in public safety, providing for 2 violence intervention and prevention; establishing the 3 Community-Based Violence Intervention and Prevention (VIP) Grant Program; imposing duties on the Pennsylvania Commission on Crime and Delinquency; and making appropriations. 6 7 This act may be referred to as the Break the Cycle of Violence Act. 9 The General Assembly of the Commonwealth of Pennsylvania 10 hereby enacts as follows: 11 Section 1. - 5 § 5701. Scope of chapter.
- 6 This chapter relates to violence intervention and prevention.
- 7 § 5702. Definitions.
- 8 The following words and phrases when used in this chapter
- 9 shall have the meanings given to them in this section unless the
- 10 context clearly indicates otherwise:
- 11 "Commission." The Pennsylvania Commission on Crime and
- 12 <u>Delinquency</u>.
- 13 "Disproportionately impacted by violence." Having any of the
- 14 <u>following characteristics of a municipality or community:</u>
- 15 <u>(1) Experiencing 10 or more homicides per year for at</u>
- least two of the three years preceding the submission of a
- 17 program grant application.
- 18 (2) Demonstrating a unique and compelling need for
- 19 additional resources to address gun and group-related
- violence within the municipality or community.
- 21 "Municipality." A city, borough, incorporated town, township
- 22 or home rule municipality.
- 23 "Program." The Community-Based Violence Intervention and
- 24 Prevention (VIP) Grant Program established under section 5703(a)
- 25 <u>(relating to grant program).</u>
- 26 § 5703. Grant program.
- 27 (a) Establishment. -- The Community-Based Violence
- 28 Intervention and Prevention (VIP) Grant Program is established
- 29 within the commission.
- 30 (b) Purpose. -- The purpose of the program is to award grants

- 1 to improve public health and safety in municipalities and
- 2 communities that are disproportionately impacted by violence by
- 3 supporting, expanding and replicating effective community-based
- 4 <u>violence reduction initiatives through strategies that:</u>
- 5 (1) Include, but are not limited to, hospital-based
- 6 violence intervention, evidence-based street outreach and
- 7 <u>focused deterrence programs.</u>
- 8 (2) Have demonstrated effectiveness at reducing gun or
- 9 group-related violence without contributing to mass_
- 10 <u>incarceration</u>.
- 11 (3) Are primarily focused on providing community-based
- 12 <u>violence intervention services to the relatively small number</u>
- of individuals within a program grantee's municipality or
- community who are identified as being at the highest risk of
- 15 perpetrating or being victimized by violence in the near_
- 16 <u>future</u>.
- 17 (c) Administration. -- The commission shall administer the
- 18 program.
- 19 (d) Public notice. -- The commission shall provide information
- 20 regarding the availability and award of program grant money on
- 21 the commission's publicly accessible Internet website.
- 22 § 5704. Advisory committee.
- 23 The commission shall form a grant selection advisory
- 24 committee that includes, but is not limited to, the following:
- 25 (1) Individuals who have been personally impacted by
- violence.
- 27 (2) Individuals with experience implementing community-
- 28 <u>based violence reduction initiatives.</u>
- 29 (3) At least three members of the Department of Health's
- 30 Office of Health Equity Advisory Committee.

- 1 § 5705. Application forms.
- 2 The commission shall develop annual grant application forms
- 3 for any municipality or community-based organization serving a
- 4 municipality that seeks a program grant. At a minimum, the forms
- 5 <u>shall contain the following information:</u>
- 6 (1) The name, address and contact information of the
- 7 <u>municipality or community-based organization.</u>
- 8 (2) The amount of program grant money requested.
- 9 (3) The proposed use for the program grant money
- 10 requested, including clearly defined and measurable
- 11 <u>objectives for the program grant money and the anticipated</u>
- 12 <u>number of individuals to be served.</u>
- 13 (4) A statement describing how the municipality or
- community-based organization proposes to use the program
- 15 grant money to implement a community-based violence reduction_
- 16 <u>initiative in accordance with the strategies described in</u>
- section 5703(b) (relating to grant program).
- 18 <u>(5) A statement describing how the municipality or</u>
- community-based organization proposes to use the program
- 20 grant money to enhance coordination with relevant
- 21 stakeholders or existing violence prevention and intervention
- 22 <u>programs and service providers in the municipality or</u>
- 23 community, if any, to achieve maximum impact and minimize
- 24 <u>duplication of services.</u>
- 25 (6) Evidence indicating that the proposed violence
- 26 reduction initiative would likely reduce the incidence of gun
- and group-related violence.
- 28 <u>(7) Any other information that the commission deems</u>
- 29 <u>necessary and appropriate.</u>
- 30 § 5706. Award of program grants.

- 1 (a) Review. -- After review of the information provided under
- 2 <u>each applicant's submitted application form, the commission</u>
- 3 shall determine whether to award grant program money to the
- 4 applicant and, if so, the amount of the program grant money
- 5 <u>awarded.</u>
- 6 (b) Competitive nature of awards. -- Program grants shall be
- 7 <u>awarded on a competitive basis to municipalities and community-</u>
- 8 based organizations that are disproportionately impacted by
- 9 violence.
- 10 (c) Considerations. -- In awarding program grants, the
- 11 <u>commission shall:</u>
- 12 (1) Give preference to applicants whose grant proposals
- demonstrate the greatest likelihood of reducing the number of
- 14 persons victimized by gun and group-related violence in their
- 15 <u>community</u>, without contributing to mass incarceration.
- 16 (2) Consider the geographic and demographic diversity of
- the applicants.
- 18 (3) Consider the scope of the applicant's proposal and
- 19 <u>the applicant's demonstrated need for additional resources to</u>
- 20 effectively reduce gun and group-related violence in the
- 21 <u>affected municipality or community.</u>
- 22 (d) Cash or in-kind match.--
- 23 (1) Subject to paragraph (2), each municipality that
- receives a program grant shall commit a cash or in-kind match
- 25 <u>that is equivalent to 25% of the cost of the program grant</u>
- 26 <u>awarded under this chapter.</u>
- 27 (2) The commission may waive the requirement under
- paragraph (1) for good cause.
- 29 (e) Distribution by municipality. -- Each municipality that
- 30 receives a program grant shall distribute at least 50% of the

- 1 program grant money to:
- 2 (1) one or more community-based organizations within the
- 3 municipality or community;
- 4 (2) a public agency or department that is not a law
- 5 enforcement agency but is primarily dedicated to community
- 6 safety or violence prevention within the municipality or
- 7 <u>community; or</u>
- 8 (3) a combination of the entities specified under
- 9 paragraphs (1) and (2).
- 10 (f) Duration. -- Subject to the availability of State funding,
- 11 a program grant shall be awarded for a duration of at least
- 12 <u>three years.</u>
- 13 <u>(g) Notice.--</u>
- 14 (1) The commission shall provide written notice to the
- applicant of the award or denial of the program grant money.
- 16 (2) Notice of the award of program grant money shall
- include the amount of the program grant money awarded and any
- 18 conditions or restrictions on the use of the program grant
- 19 money.
- 20 (3) Notice of the denial of all or part of the program
- 21 grant money requested shall include the reasons for the full
- 22 <u>or partial denial.</u>
- 23 § 5707. Appropriations.
- In addition to any amounts otherwise authorized to be
- 25 appropriated or made available to the commission, the sum of
- 26 \$10,000,000 is hereby appropriated for each of the three fiscal
- 27 years following the effective date of this section to provide
- 28 program grants.
- 29 § 5708. Administrative costs.
- 30 The commission may use up to 8% of the money appropriated for

- 1 program grants each year for the costs of administering the
- 2 program, which may include the costs relating to the employment
- 3 of personnel, providing technical assistance to grantees and
- 4 evaluating the impact of initiatives supported by the grants.
- 5 <u>§ 5709.</u> Reports.
- 6 Upon completion of each grant cycle, the commission shall
- 7 prepare and submit a report to the General Assembly regarding
- 8 the impact of violence reduction initiatives supported by the
- 9 program.
- 10 Section 2. This act shall take effect in 60 days.
