Amending Titles 27 (Environmental Resources) and 75 (Vehicles) of the Pennsylvania Consolidated Statutes, providing for Keystone Tree Fund; and, in registration of vehicles, 3 providing for contributions to the Keystone Tree Fund. 4 5 The General Assembly of the Commonwealth of Pennsylvania 6 hereby enacts as follows: 7 Section 1. - 1 The following words and phrases when used in this chapter
- 2 shall have the meanings given to them in this section unless the
- 3 context clearly indicates otherwise:
- 4 <u>"Department." The Department of Conservation and Natural</u>
- 5 Resources of the Commonwealth.
- 6 <u>"Fund." The Keystone Tree Fund established by this chapter.</u>
- 7 § 6602. Establishment.
- 8 The Keystone Tree Fund is established in the State Treasury.
- 9 The money in the fund is appropriated on a continuing basis to
- 10 the department for the purposes specified in section 6604
- 11 <u>(relating to authorized purposes).</u>
- 12 § 6603. Sources of revenue.
- 13 The fund shall include the following:
- 14 (1) Proceeds paid by the Department of Transportation
- under 75 Pa.C.S. § 1322 (relating to contributions to
- 16 <u>Keystone Tree Fund</u>).
- 17 (2) Grants, gifts, donations and other payments from a
- 18 <u>person or governmental entity to the fund.</u>
- 19 <u>(3) Money appropriated to the fund.</u>
- 20 § 6604. Authorized purposes.
- 21 The department may expend money from the fund for the
- 22 <u>purposes and in the allocations as follows:</u>
- 23 (1) A tree vitalize program, 40%.
- 24 (2) A riparian forest buffer grant program, 60%.
- 25 § 6605. Contributions.
- The department may solicit and accept gifts, donations,
- 27 legacies and other money for deposit into the fund from a person
- 28 or a government entity on behalf of the Commonwealth.
- 29 § 6606. Statement of policy.
- The department shall adopt a statement of policy for the

- 1 maintenance and use of the fund within 60 days of the effective
- 2 <u>date of this section. The statement of policy shall be published</u>
- 3 as a notice in the Pennsylvania Bulletin but shall not be
- 4 <u>subject to review under section 205 of the act of July 31, 1968</u>
- 5 (P.L.769, No.240), referred to as the Commonwealth Documents
- 6 Law, sections 204(b) and 301(10) of the act of October 15, 1980
- 7 (P.L.950, No.164), known as the Commonwealth Attorneys Act, or
- 8 the act of June 25, 1982 (P.L.633, No.181), known as the
- 9 Regulatory Review Act.
- 10 § 6607. Report.
- By July 31, 2020, and every year thereafter, the department
- 12 shall submit to the chairperson and minority chairperson of the
- 13 Environmental Resources and Energy Committee of the Senate and
- 14 the chairperson and minority chairperson of the Environmental
- 15 Resources and Energy Committee of the House of Representatives a
- 16 report detailing the fund revenues and expenditures in the prior
- 17 fiscal year and describing the activities, programs and projects
- 18 which received money from the fund.
- 19 Section 2. Title 75 is amended by adding a section to read:
- 20 § 1322. Contributions to Keystone Tree Fund.
- 21 (a) General rule. -- Within one year of the effective date of
- 22 this section the department shall provide for all of the
- 23 <u>following:</u>
- 24 (1) Ability of an applicant for an original or renewal
- 25 driver's license or identification card to make a \$3 donation
- to the Keystone Tree Fund established by 27 Pa.C.S. § 6602
- 27 <u>(relating to establishment).</u>
- 28 (2) Ability of an applicant for a renewal vehicle
- 29 registration to make a \$3 donation to the Keystone Tree Fund.
- 30 (b) Implementation.--
