AN ACT

- 1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
- act relating to the public school system, including certain
- provisions applicable as well to private and parochial
- schools; amending, revising, consolidating and changing the
- laws relating thereto," in terms and courses of study,
- 6 providing for cardiopulmonary resuscitation education.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. The act of March 10, 1949 (P.L.30, No.14), known
- 10 as the Public School Code of 1949, is amended by adding a
- 11 section to read:
- 12 Section 1528. Cardiopulmonary Resuscitation Education.--(a)
- 13 In accordance with the academic standards for health, safety and
- 14 physical education for grades nine through twelve and not later
- 15 than the beginning of the 2019-2020 school year, the department,
- 16 in consultation with the Department of Health and at least one
- 17 organization recognized under section 1205.4, shall IDENTIFY OR_ <--

- 1 <u>develop a model curriculum and curriculum quidelines for</u>
- 2 instruction on cardiopulmonary resuscitation for public school
- 3 <u>students in grades nine through twelve.</u>
- 4 (b) The model curriculum and guidelines shall:
- 5 (1) be posted in the department's publicly accessible
- 6 Internet website;
- 7 (2) be age-appropriate;
- 8 (3) be revised regularly to remain current with national
- 9 standards;
- 10 (4) provide quidance for integration into health courses or
- 11 other appropriate curriculum requirement as listed in 22 Pa.
- 12 Code § 4.23 (relating to high school education);
- 13 (5) be made available to all school entities;
- 14 (6) include compilation of recommended guidelines and
- 15 <u>educational materials from organizations with expertise in CPR</u>
- 16 and emergency care;
- 17 (7) incorporate psychomotor skills training, including
- 18 hands-only CPR technique; and
- 19 (8) include information on the purpose of an automated
- 20 external defibrillator.
- 21 (c) (1) A school entity that offers instruction in CPR may
- 22 utilize the model curriculum developed under subsections (a) and
- 23 (b) or develop the school entity's own curriculum in accordance
- 24 <u>with academic standards and consistent with guidelines developed</u>
- 25 <u>under subsections (a) and (b). A school entity may utilize</u>
- 26 appropriate publicly or privately available materials, personnel
- 27 and other resources in developing and implementing this
- 28 instruction, subject to the requirements of section 111 and 23
- 29 Pa.C.S. § 6344 (relating to employees having contact with
- 30 children; adoptive and foster parents).

- 1 (2) A teacher, instructor or community volunteer, WITH THE <--
- 2 PARTICIPATION OF A PROFESSIONAL EDUCATOR WITH A PENNSYLVANIA
- 3 CERTIFICATION, INCLUDING A PROFESSIONAL EDUCATOR CERTIFIED IN
- 4 PHYSICAL EDUCATION OR HEALTH EDUCATION OR A SCHOOL NURSE, may
- 5 provide, facilitate or oversee the instruction offered by a
- 6 school entity under this section and need not be a certified CPR
- 7 trainer.
- 8 (d) An individual who in good faith provides instruction in
- 9 CPR to a student under this section shall not be liable for any
- 10 civil damages as a result of any act or omission relating to the
- 11 instruction, except for an act or omission intentionally
- 12 <u>designed to harm or a grossly negligent act or omission that</u>
- 13 results in harm to an individual to whom the student administers
- 14 <u>CPR.</u>
- 15 (e) A cyber charter school may provide the instruction under
- 16 this section through the Internet or other electronic means. If
- 17 a cyber charter school provides the instruction under this
- 18 section through the Internet or other electronic means, the
- 19 cyber charter school shall be exempt from the academic standards
- 20 and guidelines developed under subsections (a) and (b) regarding
- 21 in-person instructional requirements.
- 22 (f) As used in this section, the following words and phrases
- 23 shall have the meanings given to them in this subsection unless
- 24 the context clearly indicates otherwise:
- 25 "Automated external defibrillator." A portable defibrillator
- 26 designed to be automated for use by a person without substantial
- 27 medical training who responds to a cardiac emergency.
- 28 "Cardiopulmonary resuscitation" or "CPR." A first aid
- 29 technique utilizing hands-only compressions of the chest used to
- 30 revive an individual whose heart has stopped beating.

- 1 <u>"Department." The Department of Education of the</u>
- 2 Commonwealth.
- 3 "Psychomotor skills." The use of hands-on practice to
- 4 <u>support cognitive learning.</u>
- 5 <u>"School entity." A school district, joint school district,</u>
- 6 <u>charter school</u>, <u>regional charter school</u>, <u>cyber charter school</u>,
- 7 intermediate unit or area vocational-technical school.
- 8 Section 2. This act shall take effect in 60 days.
