AN ACT

Amending the act of April 23, 1956 (1955 P.L.1510, No.500), entitled "An act providing for the prevention and control of 1 2 communicable and non-communicable diseases including venereal 3 diseases, fixing responsibility for disease prevention and control, requiring reports of diseases, and authorizing treatment of venereal diseases, and providing for premarital and prenatal blood tests; amending, revising and 7 consolidating the laws relating thereto; and repealing certain acts," further providing for definitions and for control measures. 10 The General Assembly of the Commonwealth of Pennsylvania 11 12 hereby enacts as follows: 13 Section 1. Section 2 of the act of April 23, 1956 (1955) 14 P.L.1510, No.500), known as the Disease Prevention and Control Law of 1955, is amended by adding a subsection to read: 15 Section 2. Definitions .--16 17 The following terms, whenever used in this act, have the 18 meanings indicated in this section, except where the context 19 indicates a clearly different meaning: 20 * * * (d.2) Facility. Any of the following: 2.1

- 2 1001 of the act of June 13, 1967 (P.L.31, No.21), known as the
- 3 "Human Services Code."

- 10 Section 2. Section 5 of the act is amended to read:
- 11 Section 5. Control Measures.--
- 12 (a) Upon the receipt by a local board or department of
- 13 health or by the department, as the case may be, of a report of
- 14 a disease which is subject to isolation, quarantine, or any
- 15 other control measure, the local board or department of health
- 16 or the department shall carry out the appropriate control
- 17 measures in such manner and in such place as is provided by rule
- 18 or regulation.
- 19 (b) The secretary must:
- 20 (1) Ensure no individual who is less than thirty days from
- 21 <u>testing positive for a communicable disease or who is less than</u>
- 22 thirty days from being asymptomatic of a communicable disease
- 23 <u>shall be admitted to a facility without being placed in</u>
- 24 isolation within the facility with dedicated personnel assigned
- 25 only to the area of isolation during the period of time in which
- 26 the personnel is working.
- 27 (2) Ensure facilities are adequately equipped to follow and
- 28 implement all recommendations and quidelines issued by the
- 29 Centers for Disease Control and Prevention and the Centers for
- 30 Medicare and Medicaid Services for the prevention and control of

- 1 <u>a communicable disease within facilities.</u>
- 2 Section 3. This act shall take effect immediately.
