- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- Statutes, in preliminary provisions, further providing for
- the definitions of "emergency service responder" and
- 4 "emergency vehicle."
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. The definitions of "emergency service responder"
- 8 and "emergency vehicle" in section 102 of Title 75 of the
- 9 Pennsylvania Consolidated Statutes, amended November 4, 2015
- 10 (P.L.227, No.61), are amended to read:
- 11 § 102. Definitions.
- 12 Subject to additional definitions contained in subsequent
- 13 provisions of this title which are applicable to specific
- 14 provisions of this title, the following words and phrases when
- 15 used in this title shall have, unless the context clearly
- 16 indicates otherwise, the meanings given to them in this section:
- 17 * * *
- "Emergency service responder." An individual acting in an

- 1 official capacity as any of the following:
- 2 (1) A police officer.
- 3 (2) A sheriff or deputy sheriff.
- 4 (3) A coroner or deputy coroner.
- 5 (4) A firefighter.
- 6 (5) Fire police.
- 7 (6) A fire marshal.
- 8 (7) A medical examiner or deputy medical examiner.
- 9 (8) Rescue personnel.
- 10 (9) Ambulance personnel.
- 11 (10) Towing and recovery personnel.
- 12 (11) Highway maintenance and construction personnel.
- 13 (12) Hazardous material response team member.
- 14 (13) Emergency medical services personnel.
- 15 (14) Contractors or employees of a public utility as
- defined under 66 Pa.C.S. § 102 (relating to definitions), a
- municipally owned utility or an electric cooperative as
- defined in 15 Pa.C.S. Ch. 73 (relating to electric
- 19 cooperative corporations).
- 20 (15) A police officer who is also a member of a county
- 21 or regional municipal Special Emergency Response Team which
- is authorized to respond to emergencies under 42 Pa.C.S. §
- 23 <u>8953 (relating to Statewide municipal police jurisdiction).</u>
- "Emergency vehicle." A State or county emergency management
- 25 vehicle, fire department vehicle, police vehicle, sheriff
- 26 vehicle, ambulance, advanced life support squad vehicle, basic
- 27 life support squad vehicle, emergency canteen support service
- 28 organization vehicle, blood delivery vehicle, human organ
- 29 delivery vehicle, hazardous material response vehicle, armed
- 30 forces emergency vehicle, one vehicle operated by a coroner or

- 1 chief county medical examiner and one vehicle operated by a
- 2 chief deputy coroner or deputy chief county medical examiner
- 3 used for answering emergency calls, a vehicle owned by or leased
- 4 to a regional emergency medical services council that is used as
- 5 authorized by the Department of Health to respond to an actual
- 6 or potential disaster, mass casualty situation or substantial
- 7 threat to public health, a vehicle owned by a county or regional
- 8 police association and operated by a police officer that is used
- 9 for police transport or victim extraction, any vehicle operated
- 10 by a special agent, special agent supervisor, narcotics agent or
- 11 narcotics agent supervisor while performing official duties as
- 12 employees of the Office of Attorney General, any vehicle owned
- 13 and operated by the Philadelphia Parking Authority established
- 14 in accordance with 53 Pa.C.S. Ch. 55 (relating to parking
- 15 authorities) and used in the enforcement of 53 Pa.C.S. Ch. 57
- 16 (relating to taxicabs and limousines in first class cities), a
- 17 vehicle owned and operated by the Pennsylvania Turnpike
- 18 Commission that is used by an emergency service responder as
- 19 dispatched by the Pennsylvania Turnpike Commission's traffic
- 20 operations center, or any other vehicle designated by the State
- 21 Police under section 6106 (relating to designation of emergency
- 22 vehicles by Pennsylvania State Police), or a privately owned
- 23 vehicle used in answering an emergency call when used by any of
- 24 the following:
- 25 (1) A police chief and assistant chief.
- 26 (2) A fire chief, assistant chief and, when a fire
- company has three or more fire vehicles, a second or third
- 28 assistant chief.
- 29 (3) A fire police captain and fire police lieutenant.
- 30 (4) An ambulance corps commander and assistant

- 1 commander.
- 2 (5) A river rescue commander and assistant commander.
- 3 (6) A county emergency management coordinator.
- 4 (7) A fire marshal.
- 5 (8) A rescue service chief and assistant chief.
- 6 (9) The chief or operations director of a county
- 7 hazardous materials response team.
- 8 (10) A police officer who is also a member of a county
- 9 <u>or regional municipal Special Emergency Response Team which</u>
- is authorized to respond to emergencies under 42 Pa.C.S. §
- 11 8953 (relating to Statewide municipal police jurisdiction).

- 13 Section 2. This act shall take effect in 60 days.
