AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain 2 provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the 4 laws relating thereto," providing for the Keystone Telepresence Education Grant Program. 6 7 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: Section 1. The act of March 10, 1949 (P.L.30, No.14), known 9 as the Public School Code of 1949, is amended by adding an 10 article to read: 11 12 ARTICLE XV-J 13 KEYSTONE TELEPRESENCE EDUCATION GRANT PROGRAM Section 1501-J. Scope of article. 14 15 This article relates to the Keystone Telepresence Education 16 Grant Program. 17 Section 1502-J. Definitions. 18 The following words and phrases when used in this article shall have the meanings given to them in this section unless the 19

- 1 <u>"Department." The Department of Education of the</u>
- 2 Commonwealth.
- 3 "Grant." A Keystone Telepresence Education Grant authorized
- 4 and awarded by the department under the program to intermediate
- 5 units in this Commonwealth.
- 6 <u>"Homebound student." A student in this Commonwealth who:</u>
- 7 (1) is unable to attend school for an extended period as
- 8 the result of a serious medical condition, including injuries
- 9 from an accident, recovery from a medical procedure, serious
- 10 illness or chronic illness; and
- 11 (2) satisfies the conditions for receipt of homebound
- 12 <u>instruction under 22 Pa. Code § 11.25 (relating to temporary</u>
- 13 <u>excusals due to illness or other urgent reasons).</u>
- 14 "Program." The Keystone Telepresence Education Grant Program
- 15 established under section 1503-J(a).
- 16 "Secretary." The Secretary of Education of the Commonwealth.
- 17 "Telepresence equipment." Available technology that enables
- 18 homebound students to participate in daily educational
- 19 activities with the students' classmates and teachers, in real-
- 20 time, from a remote location. The technology shall include audio
- 21 and video capabilities that enable homebound students to
- 22 communicate with classmates and teachers.
- "Telepresence equipment manufacturer." An entity that
- 24 manufactures telepresence equipment for the use of, among other
- 25 things, educating homebound students and provides technical
- 26 support and training for the equipment.
- 27 <u>Section 1503-J. Keystone Telepresence Education Grant Program.</u>
- 28 (a) Establishment.--The Keystone Telepresence Education
- 29 Grant Program is established for the purpose of awarding grants
- 30 to intermediate units for the purchase of telepresence equipment

- 1 and related support services for the educational support of
- 2 homebound students. The department shall:
- 3 (1) Develop guidelines for the purchase of telepresence
- 4 <u>equipment and services related to the utilization of the</u>
- 5 <u>equipment through the program, including department-approved</u>
- 6 <u>telepresence equipment manufacturers.</u>
- 7 (2) Determine the form and manner in which an
- 8 application for a grant may be filed with the department.
- 9 (3) Provide notice of the program to intermediate units.
- 10 (4) Make grant applications available to all
- 11 <u>intermediate units along with details relating to the</u>
- 12 application process.
- 13 <u>(5) Adopt guidelines for the approval of grant</u>
- 14 <u>applications</u>.
- 15 (b) Eligibility.--Each intermediate unit shall be eligible
- 16 <u>for a grant.</u>
- 17 (c) Application. -- An intermediate unit may apply for a grant
- 18 by submitting one annual application to the department. The
- 19 secretary shall determine in accordance with the guidelines of
- 20 the department the amount of a grant award to an intermediate
- 21 unit.
- 22 (d) Allocation. -- To award grants under the program, the
- 23 <u>department shall use up to \$300,000 annually of undistributed</u>
- 24 funds not expended, encumbered or committed from appropriations
- 25 for grants and subsidies made to the department to award grants.
- 26 The funds shall be transferred by the Secretary of the Budget to
- 27 <u>a restricted account as necessary to award grants and, when</u>
- 28 transferred, are hereby appropriated to carry out the provisions
- 29 in this article.
- 30 (e) Limitations.--No intermediate unit may receive an annual

- 1 grant allocation that exceeds 10% of the funds available under
- 2 the grant program.
- 3 <u>Section 1504-J. Intermediate unit policies.</u>
- 4 (a) Telepresence equipment use. -- An intermediate unit shall
- 5 <u>develop an internal policy for the use of telepresence equipment</u>
- 6 and related support services prior to applying for a grant. The
- 7 policy shall include quidelines for the process by which public
- 8 schools, nonpublic schools or other educational entities within
- 9 the intermediate unit may request the use of telepresence
- 10 equipment through an intermediate unit.
- 11 (b) Dissemination. -- An intermediate unit shall, upon
- 12 request, provide the policy under subsection (a) to a public
- 13 school, nonpublic school or other educational entity within the
- 14 intermediate unit.
- 15 (c) Policy modification. -- A public school, nonpublic school
- 16 or other educational entity within an intermediate unit may
- 17 request that the intermediate unit modify its policy for the use
- 18 of telepresence equipment and related support services to meet
- 19 the needs of a homebound student.
- 20 Section 1505-J. Use of grants.
- 21 (a) Equipment. -- An intermediate unit which is awarded a
- 22 grant shall use the grant to purchase telepresence equipment.
- 23 (b) Service and training. -- A grant may be used, in part, to
- 24 secure technical support, mechanical support and training
- 25 support related to the use of telepresence equipment.
- 26 Section 1506-J. Reports.
- 27 An intermediate unit which is awarded a grant shall submit to
- 28 the department a report detailing all expenditures related to
- 29 the use of the grant.
- 30 Section 1507-J. Prohibition.

- 1 <u>An intermediate unit that purchases telepresence equipment</u>
- 2 with a grant may not charge a public school, nonpublic school or
- 3 other educational entity within the intermediate unit for the
- 4 <u>use of the telepresence equipment when the equipment is used to</u>
- 5 support the educational needs of a homebound student.
- 6 <u>Section 1508-J. Construction.</u>
- 7 Nothing in this article shall be construed to require or
- 8 create an entitlement to telepresence equipment as a component
- 9 of an individualized education plan for any student in this
- 10 Commonwealth.
- 11 Section 2. This act shall take effect in 90 days.
