AN ACT

Amending the act of March 4, 1971 (P.L.6, No.2), entitled "An act relating to tax reform and State taxation by codifying 2 and enumerating certain subjects of taxation and imposing 3 taxes thereon; providing procedures for the payment, collection, administration and enforcement thereof; providing for tax credits in certain cases; conferring powers and imposing duties upon the Department of Revenue, certain 7 employers, fiduciaries, individuals, persons, corporations 8 and other entities; prescribing crimes, offenses and penalties," in personal income tax, providing for small 10 businesses. 11 The General Assembly of the Commonwealth of Pennsylvania 12 13 hereby enacts as follows: 14 Section 1. The act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, is amended by adding a section to 15 16 read: Section 305.1. Small Businesses.--(a) There shall be 17 18 allowed as a deduction from income for the taxable year an 19 amount equal to the net operating loss. 20 (b) In the case of any net operating loss arising in a taxable year beginning after December 31, 2017, and before 21

January 1, 2021, the following shall apply:

- 1 (1) The loss shall be a net operating loss carryback to each
- 2 of the five taxable years preceding the taxable year of such
- 3 loss.
- 4 (2) Any unused amounts shall be carrying forward to each
- 5 <u>succeeding taxable year.</u>
- 6 (c) The entire amount of the net operating loss for any
- 7 <u>taxable year shall be carried to the earliest of the taxable</u>
- 8 years to which, by reason of subsection (b), the loss may be
- 9 <u>carried</u>. The portion of the loss which shall be carried to each
- 10 of the other taxable years shall be the excess, if any, of the
- 11 amount of the loss over the sum of the taxable income for each
- 12 of the prior taxable years to which the loss may be carried. A
- 13 net loss for a taxable year may only be carried over from 2020
- 14 and thereafter for twenty taxable years. The following shall
- 15 apply:
- 16 (1) The portion of the loss which shall be carried to each
- 17 of the other taxable years shall be the excess, if any, of the
- 18 amount of the loss over the sum of the taxable income for each
- 19 of the prior taxable years to which the loss may be carried.
- 20 (2) Upon the cessation of operation of a small business, any
- 21 carryover loss may be carried forward by the taxpayer against
- 22 subsequent taxable income for twenty taxable years.
- 23 (d) The amount deductible on account of losses from sales or
- 24 exchanges of assets used in a trade or business shall not exceed
- 25 the amount includable on account of gains from sales or
- 26 exchanges of assets used in trade or business.
- 27 <u>(e) The deductions allowable by this subsection which are</u>
- 28 not attributable to a taxpayer's trade or business shall be
- 29 <u>allowed only to the extent of the amount of the income not</u>
- 30 derived from the trade or business. For purposes of this

- 1 <u>subsection any gain or loss from the sale or other</u>
- 2 disposition of:
- 3 (1) property, used in the trade or business, of a character
- 4 which is subject to the allowance for depreciation provided in
- 5 section 167 of the Internal Revenue Code of 1986; or
- 6 (2) real property, used in the trade or business, shall be
- 7 treated as attributable to the trade or business.
- 8 (f) As used in this section, the following words and phrases
- 9 shall have the meanings given to them in this subsection unless
- 10 the context clearly indicates otherwise:
- 11 "Net gain" means the sum of the gain for such year from each
- 12 class of compensation, net profits, gains, dividends, interest
- 13 <u>or income enumerated under section 303.</u>
- 14 "Net loss" means the sum of the loss for such year from each
- 15 class of compensation, net profits, gains, dividends, interest
- 16 or income enumerated under this section.
- 17 "Net operating loss" means the excess of the sum of the net
- 18 loss over the sum of the net gain for such year.
- 19 "Net operating loss carryback" means a net operating loss
- 20 that applies to a prior year's tax return.
- 21 "Net operating loss carryover" means the net operating loss
- 22 properly reported on an original or amended tax return that
- 23 applies the current year's net operating loss to future years'
- 24 net income.
- 25 "Small business" means an interest in an operating trade or
- 26 business entity, the principal purpose of which is not the
- 27 management of investments or income producing assets owned by
- 28 the entity which has employed an average of less than fifty
- 29 <u>full-time equivalent employes, or a net book value of assets</u>
- 30 totaling less than five million dollars (\$5,000,000) as of

- 1 December 31 of the taxable year in which the net operating loss
- 2 arose, and which has less than ten proprietors, partners or
- 3 <u>shareholders.</u>
- 4 "Taxable income" means a taxpayer's net income minus the net
- 5 operating loss deduction for the taxable year.
- 6 Section 2. This act shall take effect immediately.
