AN ACT

- Authorizing the Department of General Services, with the
 approval of the Department of Transportation and the
 Governor, to grant and convey to the Washington Health
 System, or its assignee, certain lands and improvements
 situate partially in the 6th Ward of the City of Washington
 and partially in South Strabane Township, Washington County;
 and making a repeal.
- 8 The General Assembly of the Commonwealth of Pennsylvania
- 9 hereby enacts as follows:
- 10 Section 1. Authorization for conveyance.
- 11 The Department of General Services, with the approval of the
- 12 Department of Transportation and the Governor, is hereby
- 13 authorized on behalf of the Commonwealth of Pennsylvania to
- 14 grant and convey to the Washington Health System, or its
- 15 assignee, the following tract of land together with any
- 16 buildings, structures or improvements thereon, situate partially
- 17 in the 6th Ward of the City of Washington, and partially in
- 18 South Strabane Township, Washington County, for \$1,150,000.00,
- 19 subject to such other terms and conditions as are to be set
- 20 forth in an agreement of sale.
- 21 Section 2. Property description.

- 1 The property to be conveyed pursuant to section 1 consists of
- 2 approximately 5.186 acres of land and improvements thereon,
- 3 bounded and described more particularly as follows:
- 4 ALL THAT CERTAIN PIECE, PARCEL OR LOT OF LAND situate
- 5 partially in the City of Washington and situate partially in
- 6 South Strabane Township, County of Washington, and Commonwealth
- 7 of Pennsylvania, bounded and described as follows:
- 8 BEGINNING at a point on the center line of State Highway
- 9 Route No. 108 (Murtland Avenue) at Station 59 plus 46.75 of the
- 10 State Highway enumeration; thence along the center of Murtland
- 11 Avenue, South 76° 37' 00" West, for a distance of two hundred
- 12 thirty-eight and ninety-seven one hundredths (238.97) feet to a
- 13 point; thence South 78° 54' 30" West for a distance of two
- 14 hundred and eleven and five one-hundredths (211.05) feet to a
- 15 point in Murtland Avenue; then by land of William McKennan
- 16 Smith and Ulysses S. Grant-Smith, the following courses and
- 17 distance North 00° 18' 30" West, for a distance of five hundred
- 18 and thirteen and twenty-three one hundredths (513.23) feet to a
- 19 point; thence North 78° 54' 30" East for a distance of two
- 20 hundred and eight and thirty two one hundredths (208.32) feet;
- 21 thence North 76° 37' 00" East for a distance of two hundred and
- 22 forty-one and six-tenths (841.60) feet to a point; thence South
- 23 00° 18' 30" East for a distance of five hundred and thirteen and
- 24 thirty-one one hundredths (513.31) feet to the place of
- 25 BEGINNING.
- 26 CONTAINING 5.1860-acres.
- 27 BEING Tax Parcel Nos. 760-005-00-01-0002-00 and 600-005-00-
- 28 00-0002-00
- 29 Section 3. Requirement for conveyance.
- The conveyance shall be made under and subject to all lawful

- 1 and enforceable easements, servitudes and rights of others,
- 2 including, but not confined to, streets, roadways and rights of
- 3 any telephone, telegraph, water, electric, gas or pipeline
- 4 companies, as well as under and subject to any lawful and
- 5 enforceable estates or tenancies vested in third persons
- 6 appearing of record, for any portion of the land or improvements
- 7 erected thereon.
- 8 Section 4. Costs and fees.
- 9 Costs and fees incidental to this conveyance shall be borne
- 10 by the Grantee.
- 11 Section 5. Deed.
- 12 The conveyance shall be by Special Warranty Deed to be
- 13 executed by the Secretary of General Services in the name of the
- 14 Commonwealth of Pennsylvania.
- 15 Section 6. Alternative disposition.
- 16 In the event that the conveyance authorized herein is not
- 17 completed within one year after the effective date of this act,
- 18 the authority to convey the property to the Washington Health
- 19 System as set forth in section 1 shall expire, and the property
- 20 may be disposed of in accordance with Article 2405-A of the act
- 21 of April 9, 1929 (P.L.177, No.175), known as The Administrative
- 22 Code of 1929.
- 23 Section 7. Deposit of proceeds.
- 24 The proceeds from the sale shall be deposited in the General
- 25 Fund.
- 26 Section 8. Repeal.
- 27 Section 5 of the act of October 24, 2018 (P.L.787, No.128),
- 28 entitled "An act authorizing the Department of General Services,
- 29 with the approval of the Governor and the Department of Military
- 30 and Veterans Affairs, to grant and convey to the Pennhurst

- 1 Memorial Preservation Alliance, or its assigns, a certain tract
- 2 of land with certain improvements on it situate in East Vincent
- 3 Township, Chester County; authorizing and directing the
- 4 Department of General Services, with the approval of the
- 5 Governor, to grant and convey to 812 Market, Inc., or its
- 6 assigns, certain lands and improvements situate in the City of
- 7 Harrisburg, Dauphin County; authorizing the Department of
- 8 Transportation, with the approval of the Governor, to grant and
- 9 convey to Two Farms Inc., certain lands situate in the
- 10 Collegeville Borough, Montgomery County; authorizing the
- 11 Department of General Services, with the approval of the
- 12 Governor, to grant and convey, at a price to be determined
- 13 through a competitive bid process, certain lands, buildings and
- 14 improvements situate in the Borough of Chambersburg, Franklin
- 15 County; authorizing the Department of General Services, with the
- 16 approval of the Department of Transportation and the Governor,
- 17 to grant and convey, at a price to be determined through a
- 18 competitive bid process, certain lands, buildings and
- 19 improvements situate partially in the 6th Ward City of
- 20 Washington and situate partially in South Strabane Township,
- 21 Washington County; and authorizing the Department of General
- 22 Services, with the approval of the Pennsylvania Historical and
- 23 Museum Commission and the Governor, to grant and convey to Jose
- 24 L. Ramos and Lisa Ramos, husband and wife, certain lands situate
- 25 in the Township of Whitemarsh, Montgomery County," is hereby
- 26 repealed.
- 27 Section 9. Effective date.
- This act shall take effect immediately.
