AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain 2 provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the 4 laws relating thereto," in duties and powers of boards of 5 school directors, further providing for school athletics, 6 publications and organizations. 7 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: Section 1. Section 511 of the act of March 10, 1949 (P.L.30, 10 11 No.14), known as the Public School Code of 1949, is amended by 12 adding a subsection to read: 13 Section 511. School Athletics, Publications, and 14 Organizations. -- * * * (q) Notwithstanding any other provision of this act or other 15 16 law to the contrary: 17 (1) A contract entered into between a board of school 18 directors and a teacher, professional employe or other 19 individual for the provision of services as a coach or member of 20 the coaching staff of an athletic team during an athletic season shall contain a provision that if: 21

- 1 (i) the entire athletic season is canceled by the board of
- 2 school directors or the superintendent, there shall be no
- 3 payment under the contract; and
- 4 (ii) a portion of the athletic season is canceled by the
- 5 board of school directors or the superintendent, there shall be
- 6 payment under the contract only on a pro rata basis for that
- 7 portion of the athletic season for which services were provided
- 8 prior to the effective date of the declaration or of the action
- 9 by the board of school directors or superintendent to cancel a
- 10 portion of the athletic season, whichever occurs first.
- 11 (2) A contract entered into between a board of school
- 12 <u>directors and a teacher, professional employe or other</u>
- 13 <u>individual for the provision of services as a leader or advisor</u>
- 14 of an organization, club, society or group of the members of any
- 15 class or school, that is not part of classroom instruction,
- 16 shall contain a provision that if:
- 17 (i) the organization, club, society or group of the members
- 18 of any class or school, that is not part of classroom
- 19 instruction, is canceled during the entire school year by the
- 20 board of school directors or the superintendent, there shall be
- 21 no payment under the contract; and
- 22 (ii) the organization, club, society or group of the members
- 23 of any class or school, that is not part of classroom
- 24 instruction, is canceled for a portion of the school year by the
- 25 board of school directors or the superintendent, there shall be
- 26 payment under the contract only on a pro rata basis for that
- 27 portion of the school year for which services were provided
- 28 prior to the effective date of the declaration or of the action
- 29 by the board of school directors or superintendent to cancel the
- 30 the organization, club, society or group of the members of any

- 1 <u>class or school</u>, that is not part of classroom instruction,
- 2 <u>whichever occurs first.</u>
- 3 (3) A contract in violation of paragraph (1) or (2) is void
- 4 <u>and unenforceable.</u>
- 5 Section 2. This act shall apply to contracts entered into,
- 6 amended or renewed after the effective date of this section.
- 7 Section 3. This act shall take effect in 60 days.
