SENATOR VANCE, PUBLIC HEALTH AND WELFARE, AS AMENDED, JUNE 22, 2016

AN ACT

- 1 Establishing a task force on lead and the hazards of lead poisoning; and authorizing a study.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Legislative findings.
- 6 The General Assembly finds as follows:
- 7 (1) The recent events in Flint, Michigan, have brought
- 8 national attention to lead levels in drinking water.
- 9 (2) Based on the 2010 census, Pennsylvania ranks fifth 10 nationally in the percentage of homes built before 1978.
- 11 (3) Based on the 2010 census, Pennsylvania ranks fifth 12 nationally in the percentage of homes built before 1950.
- 13 (4) Older homes are significantly more likely to contain 14 lead paint, lead pipes or copper pipes with lead soldering.
- 15 (5) Lead affects virtually every system in the body and 16 is particularly harmful to a child's developing brain and

- 1 nervous system.
- 2 Section 2. Definitions.
- 3 The following words and phrases when used in this act shall
- 4 have the meanings given to them in this section unless the
- 5 context clearly indicates otherwise:
- 6 "Commission." The Joint State Government Commission of the
- 7 Commonwealth.
- 8 "Department." The Department of Health of the Commonwealth.
- 9 "Task force." The lead task force established under this
- 10 act.
- 11 Section 3. Establishment and composition.
- 12 (a) Establishment.--There is established within the
- 13 commission a lead task force to provide for the purposes
- 14 authorized under subsection (b) and to make recommendations to
- 15 the Governor and the General Assembly regarding legislative,
- 16 regulatory or policy initiatives designed to protect the public
- 17 health from lead exposure.
- 18 (b) Purposes.--The purposes of the task force are to:
- 19 (1) Provide a comprehensive assessment of the health
- 20 concerns of lead on the residents of this Commonwealth.
- 21 (2) Assess and study the prevalence of lead in homes,
- schools, day-care centers, pipelines and other places in
- which lead exposure is possible.
- 24 (3) Study the remedies used by the Commonwealth and
- other states and make recommendations to the General Assembly
- on changes to laws, regulations, rules or programs to ensure
- 27 that the health of the residents of this Commonwealth is
- 28 protected from the effects of lead.
- 29 (c) Composition. -- The task force shall be composed of the
- 30 following members:

- 1 (1) The Secretary of Health, or his or her designee.
- 2 (2) The Secretary of Environmental Protection, or his or
- 3 her designee.
- 4 (3) The Secretary of Education, or his or her designee.
- 5 (4) The Secretary of Human Services, or his or her designee.
- 7 (5) The chairperson of the Pennsylvania Public Utility 8 Commission, or his or her designee.
- 9 (6) The executive director of the Pennsylvania Housing 10 and Finance Agency, or his or her designee.
- 11 (7) The Physician General of the Commonwealth, or his or 12 her designee.
- 13 (8) The executive director of the Housing Alliance of 14 Pennsylvania.
- 15 (9) Nine individuals appointed by the commission as follows:
- 17 (i) two individuals who are pediatric doctors with experience in lead poisoning;
- 19 (ii) one individual who is the parent of a child 20 with elevated lead levels;
- 21 (iii) one individual representing municipal water 22 authorities;
- 23 (iv) one individual representing rural water 24 companies;
- (v) one individual representing investor-owned water

 companies that are not owned by a municipal water

 authority or a rural water company;
- 28 (vi) one individual who is certified to remediate 29 lead in this Commonwealth;
- 30 (vii) one individual who works in maintenance in a

- 1 school in an urban school district; and
- 2 (viii) one individual who works in maintenance in a
- 3 school in a rural school district.
- 4 (10) One member of the Senate appointed by the President
- 5 pro tempore.
- 6 (11) One member of the Senate appointed by the Minority
- 7 Leader of the Senate.
- 8 (12) One member of the House of Representatives
- 9 appointed by the Speaker of the House of Representatives.
- 10 (13) One member of the House of Representatives
- appointed by the Minority Leader of the House of
- 12 Representatives.
- 13 Section 4. Powers and duties.
- 14 The task force shall work with the department to conduct a
- 15 comprehensive review and analysis of the laws, regulations,
- 16 policies and procedures of the Commonwealth and of other states
- 17 regarding an assessment of lead as a public health concern. The
- 18 task force's analysis and recommendations shall include, but not
- 19 be limited to, the following areas:
- 20 (1) An assessment of the age of this Commonwealth's
- 21 housing stock, public housing units, water pipelines, school
- 22 buildings and day-care facilities.
- 23 (2) An assessment of the threat lead exposure places on
- 24 public health.
- 25 (3) An assessment of the prevalence of lead in homes,
- schools, day-care centers and other places in which children
- spend a majority of their days.
- 28 (4) An assessment of the Commonwealth's approach to lead
- 29 testing and remediation and how it compares to other states.
- 30 (5) An assessment of the cost of remediating lead

- 1 hazards in this Commonwealth and potential funding sources
- 2 for remediation assistance programs.
- 3 (6) Other assessments of lead-related issues deemed
- 4 appropriate by the commission.
- 5 Section 5. Report.
- 6 (a) Submission. -- The task force shall submit a report
- 7 containing its findings and recommendations no later than
- 8 December 31, 2017, to the following:
- 9 (1) The Governor.
- 10 (2) The President pro tempore of the Senate.
- 11 (3) The Minority Leader of the Senate.
- 12 (4) The Speaker of the House of Representatives.
- 13 (5) The Minority Leader of the House of Representatives.
- 14 (b) Publication.--Upon submission of the report required
- 15 under subsection (a), the task force shall transmit notice of
- 16 the submission of the report to the Legislative Reference Bureau
- 17 for publication in the Pennsylvania Bulletin.
- 18 Section 6. Meetings, compensation and administrative support.
- 19 (a) Meetings.--The task force shall hold its first meeting
- 20 within 60 days of the effective date of this act and shall meet
- 21 as deemed necessary by the chairperson COMMISSION in order to
- 22 carry out the purposes of this act.
- 23 (b) Administrative support. -- The commission shall make
- 24 office space available to the task force. The commission shall
- 25 provide administrative support and any other technical
- 26 assistance required by the task force to carry out its duties
- 27 under this act.
- 28 Section 7. Expiration.
- 29 This act shall expire upon publication of the notice under
- 30 section 5(b).

- 1 Section 8. Effective date.
- 2 This act shall take effect immediately.
