## AN ACT

Amending the act of June 22, 1937 (P.L.1987, No.394), entitled 1 "An act to preserve and improve the purity of the waters of 2 the Commonwealth for the protection of public health, animal 3 and aquatic life, and for industrial consumption, and 4 recreation; empowering and directing the creation of 5 indebtedness or the issuing of non-debt revenue bonds by 6 7 political subdivisions to provide works to abate pollution; providing protection of water supply and water quality; 8 providing for the jurisdiction of courts in the enforcement 9 thereof; providing additional remedies for abating pollution 10 11 of waters; imposing certain penalties; repealing certain acts; regulating discharges of sewage and industrial wastes; 12 regulating the operation of mines and regulating the impact 13 of mining upon water quality, supply and quantity; placing 14 responsibilities upon landowners and land occupiers and to 15 maintain primary jurisdiction over surface coal mining in 16 Pennsylvania," in other pollutions and potential pollution, providing for notice of discharge endangering public health 17 18 or environment. 19 20 The General Assembly of the Commonwealth of Pennsylvania 21 hereby enacts as follows: 22 Section 1. The act of June 22, 1937 (P.L.1987, No.394),

23 known as The Clean Streams Law, is amended by adding a section

24 to read:

25 <u>Section 404. Notice of Discharge Endangering Public Health</u>

26 or Environment. -- (a) A person that spills, discharges or

27 releases a substance into the waters of this Commonwealth, or on

1	a location from which the substance is likely to enter the
2	waters of this Commonwealth, taking into account any control and
3	remedial measures, shall notify the department if the spill,
4	discharge or release is not authorized by a permit from the
5	department and is likely to render the receiving waters harmful
6	to public health or the environment as determined by reportable
7	quantities or other readily ascertainable standards adopted by
8	regulation under subsection (c).
9	(b) No later than sixty days after the effective date of
10	this section, the Environmental Quality Board shall publish for
11	public comment proposed regulations establishing reportable
12	quantities or other readily ascertainable standards by which a
13	person described in subsection (a) may determine whether a
14	spill, discharge or release is likely to render the receiving
15	waters harmful to public health or the environment.
16	(c) No later than one hundred eighty days after the
17	effective date of this section, the Environmental Quality Board
18	shall promulgate final regulations establishing reportable
19	quantities or other readily ascertainable standards by which a
20	person described in subsection (a) may determine whether a
21	spill, discharge or release is likely to render the receiving
22	waters harmful to public health or the environment.
23	Section 2. This act shall take effect in 60 days.
