AN ACT

- 1 Prohibiting bonuses for employees of Commonwealth agencies.
- 2 The General Assembly of the Commonwealth of Pennsylvania
- 3 hereby enacts as follows:
- 4 Section 1. Short title.
- 5 This act shall be known and may be cited as the Commonwealth
- 6 Agency Bonus Ban Act.
- 7 Section 2. Definitions.
- 8 The following words and phrases when used in this act shall
- 9 have the meanings given to them in this section unless the
- 10 context clearly indicates otherwise:
- 11 "Bonus." Any monetary compensation given to an employee
- 12 above and beyond the employee's annual salary or other rate of
- 13 pay. The term does not include the following:
- 14 (1) Reimbursement or payments for expenses related to
- official business, including meals, housing, uniforms, car
- 16 allowance and other expenses.
- 17 (2) Severance payments pursuant to a personnel

- 1 compensation plan, contract or collective bargaining
- 2 agreement.
- 3 (3) Payments for unused vacation or sick leave.
- 4 (4) An annual cost-of-living adjustment equivalency
- 5 payment made to an individual, at the maximum of a salary
- 6 range, adopted pursuant to a personnel compensation plan or a
- 7 collective bargaining agreement.
- 8 (5) An arbitration award.
- 9 (6) Payments made pursuant to litigation.
- 10 (7) Overtime payments required for work performed in
- 11 excess of the maximum workweek.
- 12 (8) Shift differential payments, standby or call-time
- payments or extra duty payments made pursuant to a collective
- 14 bargaining agreement.
- 15 A personnel compensation plan, contract or collective bargaining
- 16 agreement under this definition shall be in writing and shall be
- 17 open for public inspection.
- "Commonwealth agency." Any of the following:
- 19 (1) The Governor, Lieutenant Governor, Attorney General,
- 20 Auditor General, State Treasurer and the departments,
- 21 offices, boards, authorities, commissions and other agencies
- of the executive branch of the government of this
- Commonwealth, whether or not subject to the supervision and
- 24 control of the Governor.
- 25 (2) The legislative branch of the government of this
- 26 Commonwealth.
- 27 (3) Any court and any office of the unified judicial
- 28 system of this Commonwealth.
- 29 Section 3. Bonus ban.
- 30 No Commonwealth agency may pay a bonus to any of its

- 1 employees.
- 2 Section 4. Penalties.
- 3 (a) Reimbursement. -- Employees of Commonwealth agencies who
- 4 are paid a bonus after the effective date of this section shall
- 5 reimburse their employer for the full amount of the bonus.
- 6 (b) Penalty. -- An individual who intentionally approves or
- 7 authorizes a bonus prohibited by this act commits a misdemeanor
- 8 of the third degree.
- 9 (c) Effect on compensation. -- A bonus payment made in
- 10 violation of section 3 as determined by the Commonwealth agency
- 11 or by a court of competent jurisdiction shall not be deemed to
- 12 be compensation under 71 Pa.C.S. Pt. XXV (relating to retirement
- 13 for State employees and officers). This act shall not affect the
- 14 definition of "compensation" under 71 Pa.C.S. Pt. XXV or 24
- 15 Pa.C.S. Pt. IV (relating to retirement for school employees).
- 16 Section 5. Applicability.
- 17 The provisions of this act shall not abrogate any provision
- 18 of an existing collective bargaining agreement or employment
- 19 contract.
- 20 Section 6. Effective date.
- 21 This act shall take effect in 30 days.
