9	hereby enacts as follows:
10	Section 1. Section 1550 of the act of March 10, 1949
11	(P.L.30, No.14), known as the Public School Code of 1949, is
12	amended to read:
13	Section 1550. Firefighter and Emergency Service Training
14	(a) [Beginning with the 2003-2004 school year and each school
15	year thereafter, a] \underline{A} school district may offer firefighter and
16	emergency service training as credit-earning courses to students
17	of the age of sixteen (16) years or older, except as otherwise
18	provided in subsection (c). Such courses may include:
19	(1) Training as a Firefighter I from the National Board on

1 Fire Service Professional Qualifications.

2 (2) Training as an emergency medical technician pursuant to
3 the act of July 3, 1985 (P.L.164, No.45), known as the
4 "Emergency Medical Services Act."

5 (b) A school district that offers firefighter and emergency service training as credit-earning courses shall provide 6 7 transportation to and supervision during any firefighter and 8 emergency service training program that takes place off school grounds. Supervision of training shall be conducted as a 9 10 cooperative education program in accordance with the provisions 11 of 22 Pa. Code § 11.28 (relating to out-of-school programs). 12 (c) The Secondary Education Fire Training Pilot Program is 13 established. The purpose of the pilot program is to provide high 14 school students with instruction through a partnership between institutions of higher education and school districts or area 15 career and technical schools, or both, to increase the number of 16 17 individuals capable of becoming volunteer firefighters. The 18 pilot program shall be implemented in accordance with the 19 following: 20 (1) The State Fire Commissioner shall accept proposals from institutions of higher education in this Commonwealth for the 21 pilot program. From the proposals submitted, the State Fire 22 23 Commissioner shall select three institutions of higher education 24 to offer the pilot program. The State Fire Commissioner, to the greatest extent practicable, shall select one institution of 25 26 higher education each from the eastern, central and western regions of this Commonwealth. Nothing in this section shall_ 27 prohibit an institution of higher education from incorporating 28 29 emergency medical services instruction in the pilot program. 30 (2) An institution of higher education selected by the State

1	Fire Commissioner shall operate the pilot program by entering
2	into an agreement with a school district or an area career and
3	technical school, or both, for the provision of fire instruction
4	to students who are in at least the ninth grade and leading to
5	Firefighter I certification.
6	(3) A nonlapsing, restricted account is established in the
7	State Treasury, to be known as the Fire Training Fund. The State
8	Fire Commissioner may accept monetary donations and other money
9	for deposit into the Fire Training Fund from a person, business,
10	foundation, tax-exempt organization under section 501(c)(3) of
11	the Internal Revenue Code of 1986 (Public Law 99-514, 26 U.S.C.
12	<u>§ 501(c)(3)) or government entity on behalf of the Commonwealth.</u>
13	(4) Money may be appropriated to the State Fire Commissioner
14	to carry out the provisions of this subsection. Each institution
15	of higher education offering the pilot program shall receive at
16	<u>least one hundred fifty thousand dollars (\$150,000) for the</u>
17	duration of the pilot program.
18	(5) Any funds appropriated, donated or transferred under
19	this subsection and interest earned on the Fire Training Fund
20	shall be deposited into the Fire Training Fund.
21	(6) During the pilot program, the Legislative Budget and
22	Finance Committee shall conduct a survey of volunteer fire
23	companies in the municipalities surrounding the school districts
24	and area career and technical schools that participate in the
25	pilot program to determine whether the pilot program is
26	increasing the number of volunteer firefighters and any
27	additional recommendations. The results of the survey shall be
28	submitted to the chair and minority chair of the Veterans
29	Affairs and Emergency Preparedness Committee of the Senate and
