## AN ACT

- Amending the act of June 13, 1967 (P.L.31, No.21), entitled "An act to consolidate, editorially revise, and codify the public
- welfare laws of the Commonwealth," in public assistance,
- 4 providing for medical assistance reimbursement for doula
- 5 services.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. The act of June 13, 1967 (P.L.31, No.21), known
- 9 as the Human Services Code, is amended by adding a section to
- 10 read:
- 11 Section 449.2. Medical Assistance Reimbursement for Doula
- 12 Services. -- (a) The department shall provide reimbursement to a
- 13 <u>certified doula for providing childbirth education and support</u>
- 14 services, including physical and emotional support, to an
- 15 individual covered under the medical assistance program during
- 16 pregnancy, labor and delivery and up to one year postpartum.
- 17 (b) The department shall maintain a registry of certified
- 18 doulas who have met the requirements provided under subsection
- 19 (d) and are entitled to reimbursement under this section.

- 1 (c) Reimbursement under subsection (a) shall include
- 2 <u>reimbursement for travel time or mileage expenses in accordance</u>
- 3 with the annually scheduled rates determined by the Internal
- 4 Revenue Service.
- 5 (d) To be listed on the registry of certified doulas and
- 6 receive reimbursement under subsection (a), a doula shall:
- 7 (1) Receive and maintain certification by an approved
- 8 national certification agency identified by the department.
- 9 (2) Obtain additional training to be reimbursed by an
- 10 employer at a rate determined by the employer, focused on doula
- 11 care for special populations, on becoming a Medicaid
- 12 participating provider and on any additional topics as the
- 13 <u>department may require</u>.
- 14 (3) Submit the following information to the department for
- 15 the purpose of performing a background check:
- 16 <u>(i) A report of Federal criminal history record information.</u>
- 17 (ii) A report of criminal history record information from
- 18 the Pennsylvania State Police as provided under 18 Pa.C.S. Ch.
- 19 91 (relating to criminal history record information) or a
- 20 statement from the Pennsylvania State Police that the
- 21 Pennsylvania State Police central repository contains no
- 22 information relating to the individual. The criminal history
- 23 record information shall be limited to the information which is
- 24 <u>disseminated under 18 Pa.C.S. § 9121(b)(2) (relating to general</u>
- 25 regulations).
- 26 (iii) Fingerprints to the Pennsylvania State Police, its
- 27 agent or an agent approved for fingerprinting by the Federal
- 28 Government. The fingerprints may be used by the Pennsylvania
- 29 State Police to conduct a criminal background check and shall be
- 30 forwarded to the Federal Bureau of Investigation for a national

- 1 <u>criminal background check.</u>
- 2 (4) Maintain personal liability insurance.
- 3 <u>(e) The department shall:</u>
- 4 (1) Develop a Doula Advisory Board to act as a workgroup to
- 5 <u>determine the education requirements and approved accreditation</u>
- 6 entities from which a doula may receive certification. The
- 7 <u>following shall apply:</u>
- 8 (i) The Doula Advisory Board shall include a diverse
- 9 membership, including providers, administrators and community
- 10 members, including, but not limited to, the following:
- 11 (A) The secretary.
- 12 (B) A representative from the Department of State.
- 13 (C) A representative from the Office of Medical Assistance
- 14 Programs within the department.
- 15 (D) A representative from the Bureau of Family Health within
- 16 the Department of Health.
- 17 (E) A representative from the Office of Health Equity within
- 18 the Department of Health.
- 19 (F) A representative from a nationally recognized doula
- 20 <u>organization</u>.
- 21 (G) Practicing doulas in this Commonwealth.
- 22 (H) A member of the Pennsylvania Maternal Mortality Review
- 23 Committee established under the act of May 9, 2018 (P.L.118,
- 24 No.24), known as the Maternal Mortality Review Act.
- 25 (ii) The Doula Advisory Board shall be responsible for
- 26 developing and updating a list including the approved entities
- 27 <u>from which individuals seeking doula certification may gain the</u>
- 28 necessary education requirements under subsection (d) and a list
- 29 of core competencies necessary to be met through the training
- 30 curriculum. The list shall be updated on a quarterly basis and

- 1 <u>shall be published on the department's publicly accessible</u>
- 2 <u>Internet website.</u>
- 3 (iii) All departments, commissions, agencies and public
- 4 <u>authorities of the Commonwealth shall provide the Doula Advisory</u>
- 5 Board with any reasonably requested assistance or information in
- 6 <u>a timely manner in order to fulfill its duties.</u>
- 7 (iv) The Doula Advisory Board shall report the information
- 8 required under this paragraph to the department on a regular
- 9 basis.
- 10 (2) Set the rates of reimbursement for doula services
- 11 rendered to a medical assistance enrollee.
- 12 (f) The department shall seek a State plan amendment or
- 13 <u>Federal waiver from the Centers for Medicare and Medicaid</u>
- 14 Services, if needed, to allow the medical assistance program to
- 15 provide coverage for doula services in accordance with this
- 16 section.
- 17 (q) As used in this section, the term "doula" shall mean a
- 18 professional trained to provide physical, emotional and
- 19 <u>informational support to a mother before, during and after</u>
- 20 <u>childbirth</u>.
- 21 Section 2. If a necessary State plan amendment or Federal
- 22 waiver under section 449.2(f) of the act is approved by the
- 23 Centers for Medicare and Medicaid Services, the Secretary of
- 24 Human Services shall transmit notice of the approval to the
- 25 Legislative Reference Bureau for publication in the Pennsylvania
- 26 Bulletin.
- 27 Section 3. This act shall take effect as follows:
- 28 (1) Except as provided under paragraph (2), the addition
- of section 449.2 of the act shall take effect 30 days
- 30 following publication of the notice under section 2 of this

- 1 act.
- 2 (2) The addition of section 449.2(e) and (f) of the act
- 3 shall take effect immediately.
- 4 (3) The remainder of this act shall take effect
- 5 immediately.
