## AN ACT

Amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in sentencing, providing for sentencing for offenses involving violation of protection 3 4 orders or consent agreements. 5 The General Assembly of the Commonwealth of Pennsylvania 6 hereby enacts as follows: 7 Section 1. Title 42 of the Pennsylvania Consolidated Statutes is amended by adding a section to read: 8 § 9720.9. Sentencing for offenses involving violation of 9 10 protection orders or consent agreements. 11 (a) Sentencing enhancement. -- The Pennsylvania Commission on 12 Sentencing, in accordance with section 2154 (relating to adoption of guidelines for sentencing), shall provide for a 13 sentencing enhancement for an offense under subsection (b) when, 14 15 at the time of the commission of the offense, the defendant was 16 in violation of a protection order or consent agreement issued by a court in favor of the victim against the defendant under 17 Chapter 62A (relating to protection of victims of sexual 18
