## AN ACT

- 1 Amending Title 35 (Health and Safety) of the Pennsylvania
- 2 Consolidated Statutes, in volunteer firefighters, further
- providing for definitions, for statement of purpose, for
- 4 funds and for audits.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 7412 of Title 35 of the Pennsylvania
- 8 Consolidated Statutes is amended by adding definitions to read:
- 9 § 7412. Definitions.
- 10 The following words and phrases when used in this subchapter
- 11 shall have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:
- 13 <u>"Commissioner." The Office of the State Fire Commissioner.</u>

- 15 <u>"Length of service award program." A system established to</u>
- 16 provide tax-deferred income benefits to active volunteer members
- 17 of a fire service.

- 5 The purpose of this subchapter is to encourage individuals to
- 6 take part in the fire service as volunteer firefighters by
- 7 establishing criteria and standards for orderly administration
- 8 and conduct of affairs of firefighters' relief associations to
- 9 ensure, as far as circumstances will reasonably permit, that
- 10 funds shall be available for the <u>assistance to and</u> protection of
- 11 volunteer firefighters and their heirs in order to provide:

- 13 (4) Safeguards for preserving life, health and safety of
- volunteer firefighters to ensure their availability to
- participate in the fire service, including necessary

- and safety of volunteer firefighters to ensure their

- 8 Section 4. Section 7418 of Title 35 is amended to read:
- 9 § 7418. Audits.
- 10 (a) General rule.--
- 11 (1) The Office of Auditor General shall have the power
- and its duty shall be to audit the accounts and records of
- every volunteer firefighters' relief association receiving
- money under Chapter 7 of the act of December 18, 1984
- 15 (P.L.1005, No.205), known as the Municipal Pension Plan
- 16 Funding Standard and Recovery Act, as far as may be necessary
- 17 to satisfy the Auditor General that the money received was or
- is being expended for no purpose other than that authorized
- by this subchapter. Copies of all audits shall be furnished
- 20 to the Governor.
- 21 (2) The commissioner shall establish and publish
- 22 annually, in consultation with the Auditor General, eligible
- 23 <u>uses of the money in accordance with this subchapter.</u>
- 24 (3) Notwithstanding paragraph (1), the commissioner
- 25 shall maintain authority relating to the eligible uses of
- 26 money received.
- 27 (b) Findings.--If the Auditor General finds that [any] money
- 28 received by a volunteer firefighters' relief association has
- 29 been expended for a purpose other than one authorized by this
- 30 subchapter, the Auditor General shall immediately notify the

- 1 Governor <u>and the commissioner</u> and shall decline to approve
- 2 further requisitions calling for payment to the volunteer
- 3 firefighters' relief association until the improperly expended
- 4 amount has been reimbursed to the relief association fund.
- 5 Section 5. This act shall take effect in 60 days.
