AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
- act relating to the public school system, including certain
- provisions applicable as well to private and parochial
- schools; amending, revising, consolidating and changing the
- laws relating thereto," in charter schools, establishing the Charter School Funding Advisory Commission.

- The General Assembly of the Commonwealth of Pennsylvania
- hereby enacts as follows: 8
- 9 Section 1. The act of March 10, 1949 (P.L.30, No.14), known
- 10 as the Public School Code of 1949, is amended by adding a
- 11 section to read:
- Section 1704-A. Charter School Funding Advisory 12
- Commission. -- (a) The Charter School Funding Advisory Commission 13
- 14 is established.
- 15 (b) The commission shall examine all current laws,
- 16 regulations and executive policy statements which determine
- funding for charter schools, regional charter schools and cyber 17
- 18 charter schools in this Commonwealth.
- 19 (c) The commission shall consist of the following:

- 1 (1) The secretary or a designee.
- 2 (2) One member appointed by the President pro tempore of the
- 3 Senate.
- 4 (3) One member appointed by the Minority Leader of the
- 5 Senate.
- 6 (4) One member appointed by the Speaker of the House of
- 7 Representatives.
- 8 (5) One member appointed by the Minority Leader of the House
- 9 <u>of Representatives.</u>
- 10 (6) The chairperson and minority chairperson of the
- 11 Appropriations Committee of the Senate and the chairperson and
- 12 minority chairperson of the Appropriations Committee of the
- 13 <u>House of Representatives.</u>
- 14 (7) The chairperson and minority chairperson of the
- 15 Education Committee of the Senate and the chairperson and
- 16 minority chairperson of the Education Committee of the House of
- 17 Representatives.
- 18 (d) The commission shall hold its organizational meeting not
- 19 later than sixty (60) days following the effective date of this
- 20 section. All members shall be appointed within thirty (30) days
- 21 of the effective date of this section. Any vacancy on the
- 22 commission shall be filled by the original appointing authority.
- 23 <u>(e) The commission shall elect two commission chairpersons,</u>
- 24 one from the Senate and one from the House of Representatives.
- 25 (f) The commission shall hold meetings at the call of the
- 26 chairpersons. The commission shall hold six (6) or more public
- 27 <u>hearings on the matters to be considered by the commission. All</u>
- 28 meetings and public hearings of the commission shall be deemed
- 29 public meetings for the purpose of 65 Pa.C.S. Ch. 7 (relating to
- 30 open meetings). Seven (7) members of the commission shall

- 1 constitute a quorum at any meeting.
- 2 (q) The commission members shall receive no compensation for
- 3 their services but shall be reimbursed for all necessary travel
- 4 and other reasonable expenses incurred in connection with the
- 5 performance of their duties as members.
- 6 (h) The commission shall have the following powers and
- 7 duties:
- 8 (1) To meet with current charter school entity operators and
- 9 personnel, school district personnel and other representatives
- 10 of public education.
- 11 (2) To review charter school entity financing laws in
- 12 <u>operation throughout the United States.</u>
- 13 (3) To assess the actual cost of educating a child in a
- 14 <u>charter school</u>, a regional charter school, a cyber charter
- 15 <u>school and a school district or intermediate unit utilizing</u>
- 16 cyber classes.
- 17 (4) To evaluate and make recommendations on the following:
- 18 (i) The process by which charter schools, regional charter
- 19 schools and cyber charter schools are funded.
- 20 (ii) Appropriate funding for charter school, regional
- 21 charter school and cyber charter school operations.
- 22 (iii) Appropriate funding for charter school, regional
- 23 <u>charter school and cyber charter school facilities and</u>
- 24 management.
- 25 (iv) Appropriate funding for regular and special education
- 26 transportation.
- 27 (v) Other funding issues raised in the course of public
- 28 hearings.
- 29 <u>(vi) Consideration of a school district deduction for</u>
- 30 programs and services to the extent that they are funded from

- 1 the proceeds of competitive grants from private or public
- 2 resources or from contributions or donations from private
- 3 sources.
- 4 (vii) The appropriate manner of funding for a charter school
- 5 that primarily serves adjudicated youth.
- 6 (viii) Appropriate funding for athletic programs and
- 7 extracurricular activities offered to a student enrolled in a
- 8 <u>charter school, regional charter school or cyber charter school.</u>
- 9 <u>(ix) Appropriate funding for charter school, regional</u>
- 10 charter school and cyber charter school special education
- 11 programs.
- 12 <u>(i) The General Assembly shall provide administrative</u>
- 13 support, meeting space and any other assistance required by the
- 14 commission to carry out its duties under this section. Whenever
- 15 possible, the commission shall utilize the services and
- 16 expertise of existing personnel and staff of State government.
- 17 (j) The commission shall, no later than eighteen (18) months
- 18 from the effective date of this section, issue a report of its
- 19 <u>findings and recommendations to the Governor, the President pro</u>
- 20 tempore of the Senate, the Majority Leader of the Senate, the
- 21 Minority Leader of the Senate, the Speaker of the House of
- 22 Representatives, the Majority Leader of the House of
- 23 Representatives and the Minority Leader of the House of
- 24 Representatives. The recommendations of the commission shall not
- 25 take effect unless the recommendations are approved by an act of
- 26 the General Assembly enacted after the effective date of this
- 27 section.
- 28 (k) As used in this section, the term "commission" means the
- 29 <u>Charter School Funding Advisory Commission.</u>
- 30 Section 2. This act shall take effect immediately.
