- Amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in minors, further providing for the 2 offense of misrepresentation of age to secure liquor or malt 3 or brewed beverages, for the offense of purchase, consumption, possession or transportation of liquor or malt 5 or brewed beverages and for the offense of carrying a false 6 identification card. 7 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 Section 1. Sections 6307(b), 6308(b) and 6310.3(b) of Title 11 18 of the Pennsylvania Consolidated Statutes are amended and the sections are amended by adding subsections to read: 12 13 § 6307. Misrepresentation of age to secure liquor or malt or 14 brewed beverages. 15 (b) Minimum penalty.--[A] <u>In addition to the penalty imposed</u> 16 17 under subsection (b.1), a person who is convicted of violating 18 subsection (a) may be sentenced to pay a fine of not more than 19 \$500 for the first violation and not more than \$1,000 for
- 20 subsequent violations. No court shall have the authority to

- 1 suspend any sentence as defined in this section.
