AS REPORTED FROM COMMITTEE ON STATE GOVERNMENT, HOUSE OF REPRESENTATIVES, AS AMENDED, JUNE 19, 2019

## AN ACT

Authorizing and directing the Department of General Services, 1 with the approval of the Governor, to grant and convey 2 certain lands and improvements situate in the City of 3 Allentown and the City of Bethlehem, Lehigh County, through a competitive solicitation process; and making a related 5 6 repeal. 7 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 8 Section 1. Conveyances in City of Allentown and City of 10 Bethlehem. Authorization. -- The Department of General Services, with 11 12 the approval of the Governor, is authorized and directed on 13 behalf of the Commonwealth of Pennsylvania to grant and convey the following tracts of land together with any improvements 14 15 thereon, known as the former Allentown State Hospital, situate 16 in the City of Allentown and City of Bethlehem, Lehigh County, 17 through a competitive solicitation for proposal process to 18 evaluate and select a buyer based upon best value and return on

investment POST-DEMOLITION, which, in addition to price, may

1 include the proposed use of the property POST-DEMOLITION, job

- 2 creation, return to the property tax rolls and other criteria
- 3 specified in the solicitation documents. A competitive
- 4 solicitation committee shall be established to review proposals
- 5 and recommend a buyer. The competitive solicitation committee
- 6 shall be comprised of the Secretary of General Services or their
- 7 designee, the member of the Senate in whose district the
- 8 majority of the property is located or their designee, the
- 9 member of the House of Representatives in whose district the
- 10 majority of the property is located or their designee and an
- 11 official representative of the municipality in which the
- 12 majority of the property is located or its designee.
- 13 (b) Property description. -- The property to be conveyed under
- 14 subsection (a) consists of approximately 195.167 acres of land

- 26 (c) Condition precedent to property disposition. -- Prior to
- 27 the competitive solicitation process under subsection (a) and
- 28 notwithstanding any other provision of law, the Department of
- 29 General Services is authorized and directed to demolish all
- 30 buildings and structures located on the property, with the

- 1 exception of a Commonwealth-owned air monitoring station,
- 2 utilizing funds appropriated in section 3(7)(ii)(A) of the act
- 3 of October 30, 2017 (P.L.831, No.52), known as the Capital
- 4 Budget Project Itemization Act of 2017-2018. The Department of
- 5 General Services shall use the competitive sealed proposal
- 6 method of procurement authorized by 62 Pa.C.S. § 513 (relating
- 7 to competitive sealed proposals) to enter into a design/build
- 8 contract to undertake the demolition of the buildings and
- 9 structures.
- 10 (d) Preemption of local ordinances. -- The demolition of the
- 11 buildings and structures on the property and additional work
- 12 ancillary to the demolition of the buildings and structures on
- 13 the property by the Department of General Services are
- 14 authorized notwithstanding zoning ordinances, land use
- 15 ordinances, building codes or other regulations adopted or
- 16 enacted by a political subdivision under the authority of any
- 17 statute or under the authority of a charter or home rule charter
- 18 authorized and adopted under any statute or the Constitution of
- 19 Pennsylvania.
- 20 (e) Requirement for conveyance. -- The conveyance shall be
- 21 made under and subject to all lawful and enforceable easements,
- 22 servitudes and rights of others, including, but not confined to,
- 23 streets, roadways and rights of any telephone, telegraph, water,
- 24 electric, gas or pipeline companies, as well as under and
- 25 subject to any lawful and enforceable estates or tenancies
- 26 vested in third persons appearing of record, for any portion of
- 27 the land or improvements erected thereon.
- 28 (f) Gaming restriction. -- A conveyance authorized under this
- 29 section shall be made under and subject to the condition, which
- 30 shall be contained in the deed of conveyance, that no portion of

- 1 the property conveyed shall be used as a licensed facility, as
- 2 defined in 4 Pa.C.S. § 1103 (relating to definitions), or any
- 3 other similar type of facility authorized under State law. The
- 4 condition shall be a covenant running with the land and shall be
- 5 binding upon the grantee, it successors or assigns. Should the
- 6 grantee, its successors or assigns permit any portion of the
- 7 property authorized to be conveyed in this act to be used in
- 8 violation of this subsection, the title shall immediately revert
- 9 to and revest in the grantor.
- 10 (g) Covenants, conditions and restrictions. -- The Secretary
- 11 of General Services may impose covenants, conditions,
- 12 restrictions or reservations on the sale of the property as is
- 13 deemed in the best interests of the Commonwealth.
- 14 (h) Easements. -- The Secretary of General Services may grant
- 15 or retain any easements necessary to effectuate this section.
- 16 (i) Deed.--The conveyance shall be by special warranty deed
- 17 that shall be executed by the Secretary of General Services in
- 18 the name of the Commonwealth of Pennsylvania.
- 19 (j) Proceeds.--All proceeds from the sale of the property
- 20 shall be deposited into the General Fund.
- 21 Section 2. Repeal.
- 22 Repeals are as follows:
- 23 (1) The General Assembly declares that the repeal under
- 24 paragraph (2) is necessary to effectuate section 1.
- 25 (2) Section 1 of the act of December 22, 2017 (P.L.1268,
- 26 No.82) entitled "An act authorizing and directing the
- 27 Department of General Services, with the approval of the
- Governor, to grant and convey to TCA Properties, L.P.,
- 29 certain lands and improvements situate in the City of
- 30 Allentown and the City of Bethlehem, Lehigh County; and

- 1 authorizing the Department of General Services, with the
- 2 approval of the Department of Military and Veterans Affairs
- 3 and the Governor, to grant and convey, at a price to be
- determined through a competitive bid process, certain lands,
- 5 buildings and improvements situate in the Borough of Kane,
- 6 McKean County," is repealed.
- 7 Section 3. Effective date.
- 8 This act shall take effect immediately.
