7 Section 1. Section 502(c) and (d) of Title 45 of the

8 Pennsylvania Consolidated Statutes are amended to read:

9 § 502. Joint Committee on Documents.

- 11 (c) Quorum and organization. -- [Four] A majority of the
- 12 members of the joint committee shall constitute a quorum, and
- 13 the committee shall select from among its members a chairman and
- 14 a vice-chairman, and shall elect a secretary who need not be a
- 15 member of the committee.
- 16 (d) Powers and duties.--
- 17 <u>(1)</u> The joint committee shall exercise the powers and
- 18 perform the duties vested in and imposed upon it by this part
- and any other powers and duties vested in and imposed upon

1	the <u>joint</u> committee by law.
2	(2) In discharging its function under section 7.1 of the
3	act of June 25, 1982 (P.L.633, No.181), known as the
4	Regulatory Review Act, if the joint committee determines that
5	a document should be promulgated as a regulation and orders
6	the agency to promulgate the document as a regulation by the
7	statutory deadline, the following apply:
8	(i) Subject to subparagraph (ii), the joint
9	committee may extend the promulgation deadline for up to
10	180 days if it determines that the agency is making a
11	good faith effort to promulgate the regulation in
12	accordance with:
13	(A) section 612 of the act of April 9, 1929
14	(P.L.177, No.175), known as The Administrative Code
15	<u>of 1929;</u>
16	(B) Article II of the act of July 31, 1968
17	(P.L.769, No.240), referred to as the Commonwealth
18	Documents Law;
19	(C) sections 204(b) and 301(10) of the act of
20	October 15, 1980 (P.L.950, No.164), known as the
21	Commonwealth Attorneys Act; and
22	(D) sections 5, 5.1, 5.2, 6, 7 and 8 of the
23	Regulatory Review Act.
24	(ii) No more than two extensions may be made.
25	Regardless of extensions, the promulgation deadline may
26	not extend beyond 18 months of the date of the original
27	order.
