Amending Title TITLES 18 (Crimes and Offenses) AND 53 <--1 (MUNICIPALITIES GENERALLY) of the Pennsylvania Consolidated 2 Statutes, in minors, further providing for the offense of sale of tobacco; AND, IN PREEMPTIONS RELATING TO MUNICIPALITIES, FURTHER PROVIDING FOR TOBACCO. 5 6 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 8 Section 1. The definition of "tobacco product" in section 6305(k) of Title 18 of the Pennsylvania Consolidated Statutes is 10 amended to read: 11 § 6305. Sale of tobacco. 12 13 (k) Definitions. -- As used in this section, the following words and phrases shall have the meanings given to them in this 15 subsection: 16 * * * "Tobacco product." [A cigarette, cigar, pipe tobacco or 17 other smoking tobacco product or smokeless tobacco in any form, 18

- 1 manufactured for the purpose of consumption by a purchaser, and
- 2 any cigarette paper or product used for smoking tobacco.] The
- 3 term includes:
- 4 (1) Any product containing, made or derived from tobacco
- 5 <u>or nicotine that is intended for human consumption, whether</u>
- 6 smoked, heated, chewed, absorbed, dissolved, inhaled,
- 7 <u>snorted, sniffed or ingested by any other means, including,</u>
- but not limited to, a cigarette, a cigar, a little cigar,
- 9 <u>chewing tobacco, pipe tobacco, snuff and snus.</u>
- 10 (2) Any electronic device that delivers nicotine or
- other substance to the person inhaling from the device,
- 12 <u>including, but not limited to, an electronic cigarette, a</u>
- cigar, pipe and hookah.
- 14 The term includes any component, part or accessory of such
- 15 product or electronic device, whether or not sold separately.
- 16 The term does not include a product that has been approved by
- 17 the United States Food and Drug Administration for sale as a
- 18 tobacco cessation product or for other therapeutic purposes
- 19 where the product is marketed and sold solely for such approved
- 20 purpose.
