## AN ACT

13	(1.1) In ordering partial physical custody or supervised
14	physical custody to a party who has standing under section
15	5325(2), the court shall consider the following:
16	(i) the amount of personal contact between the child
17	and the party prior to the filing of the action;
18	(ii) whether the award interferes with any parent-
19	<pre>child relationship; and</pre>
20	(iii) whether the award is in the best interest of
21	the child.
22	(2) In ordering partial physical custody or supervised
23	physical custody to a parent's parent or grandparent who has
24	standing under section 5325(3), the court shall consider
25	whether the award:
26	(i) interferes with any parent-child relationship;
27	and
28	(ii) is in the best interest of the child.
29	Section 2. The amendment of 23 Pa.C.S. § 5328(c) shall apply
30	to:

- 1 (1) Any action regarding custody of a child under 23
- 2 Pa.C.S. Ch. 53 that is filed on or after the effective date
- 3 of this section.
- 4 (2) Any petition to modify a custody order under 23
- 5 Pa.C.S. Ch. 53 that is filed on or after the effective date
- 6 of this section.
- 7 Section 3. This act shall take effect in 60 days.
