- Amending the act of July 2, 2014 (P.L.876, No.98), entitled "An act designating a bridge on that portion of State Route 15 2 over the Yellow Breeches Creek, Carroll Township, York 3 County, as the Glenn Bowers Memorial Bridge; designating a 4 bridge on that portion of 17th Street over the 10th Avenue 5 Expressway, City of Altoona, Blair County, as the Blair 6 County Veterans Memorial Bridge; designating a bridge on that portion of State Route 764 over 31st Street, City of Altoona, 7 8 Blair County, as the Alvin E. Morrison Memorial Bridge; 9 designating West Erie Avenue from its intersection with North 10 11 Second Street in Philadelphia City, Philadelphia County, to the point where it meets North Front Street in Philadelphia 12 City, Philadelphia County, as Roberto Clemente Way; 13 designating the interchange at the crossing of State Route 33 14 and Main Street (State Route 1022) in Palmer Township, 15 Northampton County, as the Charles Chrin Interchange; 16 17 designating the interchange between the portion of State Route 3009 and State Route 119 in South Union Township, Fayette County, as the Fred L. Lebder Interchange; and 18 19 designating a bridge on that portion of State Route 711 over 20 21 the Youghiogheny River in the City of Connellsville, Fayette County, as the Officer Robb McCray Memorial Bridge," further 22 providing for Officer Robb McCray Memorial Bridge. 23 24 The General Assembly of the Commonwealth of Pennsylvania 25 hereby enacts as follows: 26 Section 1. - 11 1022) in Palmer Township, Northampton County, as the Charles
- 12 Chrin Interchange; designating the interchange between the
- 13 portion of State Route 3009 and State Route 119 in South Union
- 14 Township, Fayette County, as the Fred L. Lebder Interchange; and
- 15 designating a bridge on that portion of State Route 711 over the
- 16 Youghiogheny River in the City of Connellsville, Fayette County,
- 17 as the Officer Robb McCray Memorial Bridge," is amended to read:

- 19 Designating a bridge on that portion of State Route 15 over the
- 20 Yellow Breeches Creek, Carroll Township, York County, as the
- 21 Glenn Bowers Memorial Bridge; designating a bridge on that
- portion of 17th Street over the 10th Avenue Expressway, City
- of Altoona, Blair County, as the Blair County Veterans
- Memorial Bridge; designating a bridge on that portion of
- 25 State Route 764 over 31st Street, City of Altoona, Blair
- County, as the Alvin E. Morrison Memorial Bridge; designating
- 27 West Erie Avenue from its intersection with North Second
- Street in Philadelphia City, Philadelphia County, to the
- 29 point where it meets North Front Street in Philadelphia City,
- 30 Philadelphia County, as Roberto Clemente Way; designating the

- 1 interchange at the crossing of State Route 33 and Main Street
- 2 (State Route 1022) in Palmer Township, Northampton County, as
- 3 the Charles Chrin Interchange; designating the interchange
- 4 between the portion of State Route 3009 and State Route 119
- in South Union Township, Fayette County, as the Fred L.
- 6 Lebder Interchange; and designating a bridge on that portion
- of State Route 711 over the Youghiogheny River in the City of
- 8 Connellsville, Fayette County, as the Officer [Robb McCray]
- 9 <u>McCray Robb</u> Memorial Bridge.
- 10 Section 2. Section 7 of the act is amended to read:
- 11 Section 7. Officer [Robb McCray] McCray Robb Memorial Bridge.
- 12 (a) Findings. -- The General Assembly finds as follows:
- 13 (1) Officer [Robb McCray] McCray Robb served honorably
- as a member of the City of Connellsville Police Department,
- and was a veteran of the Civil War and served with the 110th
- 16 Pennsylvania Volunteer Infantry Regiment.
- 17 (2) While bravely performing his duties, Officer
- [McCray] Robb was killed on May 25, 1892, when he was shot
- 19 while assisting another officer arrest two brothers at a
- 20 circus that was visiting Connellsville.
- 21 (b) Designation. -- The bridge located on State Route 711,
- 22 known as Crawford Avenue, in the City of Connellsville, Fayette
- 23 County, over the Youghiogheny River is hereby designated the
- 24 Officer [Robb McCray] McCray Robb Memorial Bridge.
- 25 (c) Signs.--The Department of Transportation shall erect and
- 26 maintain appropriate signs displaying the name of the bridge to
- 27 traffic in both directions on the bridge.
- 28 Section 3. This act shall take effect immediately.
