15	(1) THE COMMONWEALTH AND LOCAL AUTHORITIES WITH RESPECT <
16	TO HIGHWAYS AND BRIDGES UNDER THEIR JURISDICTIONS MAY
17	PROHIBIT THE OPERATION OF VEHICLES AND MAY IMPOSE
18	RESTRICTIONS AS TO THE WEIGHT OR SIZE OF VEHICLES OPERATED
19	UPON A HIGHWAY OR BRIDGE ONLY WHEN THEY DETERMINE BY
20	CONDUCTING AN ENGINEERING AND TRAFFIC STUDY AS PROVIDED FOR

- (3) THE DEPARTMENT [MAY] SHALL ISSUE A STATEMENT OF <POLICY, WHICH SHALL TAKE EFFECT UPON PUBLICATION IN THE
  PENNSYLVANIA BULLETIN, ADOPTING AN APPROPRIATE METHODOLOGY TO
  PROVIDE LETTERS OF LOCAL DETERMINATION THAT IDENTIFY
  PARTICULAR VEHICLES, ROUTES OR USES AS LOCAL IN NATURE.
- (4) THE METHODOLOGY UNDER PARAGRAPH (3) [MAY] SHALL
  ALLOW FOR EXEMPTIONS FROM 67 PA. CODE CH. 189 (RELATING TO
  HAULING IN EXCESS OF POSTED WEIGHT LIMIT) RELATED TO THE ATRISK INDUSTRY OF LOGGING OR OTHER FOREST PRODUCTS
  EXPERIENCING A 20% DECLINE IN STATEWIDE EMPLOYMENT BETWEEN
  MARCH 2002 AND MARCH [2011] 2019, AS DETERMINED BY THE
  DEPARTMENT OF LABOR AND INDUSTRY.
- (5) [THE EXEMPTIONS AND RELATED REQUIREMENTS UNDER PARAGRAPH (4) MAY REMAIN IN EXISTENCE ONLY UNTIL DECEMBER 31, 2023.] EXEMPTIONS FOR LOCAL DELIVERY OR PICKUP MAY NOT INCLUDE TRAFFIC GOING TO OR COMING FROM A SITE AT WHICH MINERALS, NATURAL GAS OR NATURAL RESOURCES ARE DEVELOPED,

- 1 HARVESTED OR EXTRACTED, NOTWITHSTANDING WHETHER THE SITE IS
