A JOINT RESOLUTION

- 1 Proposing an amendment to the Constitution of the Commonwealth
- of Pennsylvania, in the legislature, further providing for
- 3 sessions.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby resolves as follows:
- 6 Section 1. The following amendment to the Constitution of
- 7 Pennsylvania is proposed in accordance with the provisions of
- 8 Article XI:
- 9 That section 4 of Article II be amended to read:
- 10 § 4. Sessions.
- 11 (a) The General Assembly shall be a continuing body during
- 12 the term for which its Representatives are elected. It shall
- 13 meet at 12 o'clock noon on the first Tuesday of January each
- 14 year. Special sessions shall be called by the Governor on
- 15 petition of a majority of the members elected to each House or
- 16 may be called by the Governor whenever in his opinion the public
- 17 interest requires.
- 18 (b) Unless meeting in special session, the General Assembly

- 1 may not convene a voting session from a time period beginning on
- 2 the first Tuesday after the first Monday in November through
- 3 November 30 in any even-numbered year.
- 4 Section 2. (a) Upon the first passage by the General
- 5 Assembly of this proposed constitutional amendment, the
- 6 Secretary of the Commonwealth shall proceed immediately to
- 7 comply with the advertising requirements of section 1 of Article
- 8 XI of the Constitution of Pennsylvania and shall transmit the
- 9 required advertisements to two newspapers in every county in
- 10 which such newspapers are published in sufficient time after
- 11 passage of this proposed constitutional amendment.
- 12 (b) Upon the second passage by the General Assembly of this
- 13 proposed constitutional amendment, the Secretary of the
- 14 Commonwealth shall proceed immediately to comply with the
- 15 advertising requirements of section 1 of Article XI of the
- 16 Constitution of Pennsylvania and shall transmit the required
- 17 advertisements to two newspapers in every county in which such
- 18 newspapers are published in sufficient time after passage of
- 19 this proposed constitutional amendment. The Secretary of the
- 20 Commonwealth shall submit this proposed constitutional amendment
- 21 to the qualified electors of this Commonwealth at the first
- 22 primary, general or municipal election which meets the
- 23 requirements of and is in conformance with section 1 of Article
- 24 XI of the Constitution of Pennsylvania and which occurs at least
- 25 three months after the proposed constitutional amendment is
- 26 passed by the General Assembly.
