AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the 4 laws relating thereto," in duties and powers of boards of 5 school directors, further providing for school athletics, 6 publications and organizations. 7 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: Section 1. Section 511 of the act of March 10, 1949 (P.L.30, 10 11 No.14), known as the Public School Code of 1949, is amended by 12 adding a subsection to read: 13 Section 511. School Athletics, Publications, and 14 Organizations. --15 (g) Notwithstanding any other provision of this act or other 16 17 <u>law to the contrary:</u> 18 (1) A contract entered into between a board of school 19 directors and a teacher, professional employe or other 20 individual for the provision of services as a coach or member of the coaching staff of an athletic team during an athletic season 21

- 1 <u>shall contain a provision that if:</u>
- 2 (i) the entire athletic season is canceled by the board of
- 3 <u>school directors or the superintendent, there shall be no</u>
- 4 payment under the contract; and
- 5 (ii) a portion of the athletic season is canceled by the
- 6 board of school directors or the superintendent, there shall be
- 7 payment under the contract only on a pro rata basis for that
- 8 portion of the athletic season for which services were provided
- 9 prior to the effective date of the declaration or of the action
- 10 by the board of school directors or superintendent to cancel a
- 11 portion of the athletic season, whichever occurs first.
- 12 (2) A contract entered into between a board of school
- 13 <u>directors and a teacher, professional employe or other</u>
- 14 <u>individual for the provision of services as a leader or advisor</u>
- 15 of an organization, club, society or group of the members of any
- 16 class or school, that is not part of classroom instruction,
- 17 shall contain a provision that if:
- 18 (i) the organization, club, society or group of the members
- 19 of any class or school, that is not part of classroom
- 20 instruction, is canceled during the entire school year by the
- 21 board of school directors or the superintendent, there shall be
- 22 no payment under the contract; and
- 23 (ii) the organization, club, society or group of the members
- 24 of any class or school, that is not part of classroom
- 25 instruction, is canceled for a portion of the school year by the
- 26 board of school directors or the superintendent, there shall be
- 27 payment under the contract only on a pro rata basis for that
- 28 portion of the school year for which services were provided
- 29 prior to the effective date of the declaration or of the action
- 30 by the board of school directors or superintendent to cancel the

- 1 the organization, club, society or group of the members of any
- 2 class or school, that is not part of classroom instruction,
- 3 whichever occurs first.
- 4 (3) A contract in violation of paragraph (1) or (2) is void
- 5 and unenforceable.
- 6 Section 2. This act shall apply to contracts entered into,
- 7 amended or renewed after the effective date of this section.
- 8 Section 3. This act shall take effect in 60 days.
