AN ACT

- 1 Amending Titles 18 (Crimes and Offenses) and 42 (Judiciary and
- Judicial Procedure) of the Pennsylvania Consolidated
- 3 Statutes, in assault, further providing for the offense of
- 4 ethnic intimidation; and, in particular rights and
- 5 immunities, further providing for civil rights violations.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Section 2710 heading, (a) and (c) of Title 18 of
- 9 the Pennsylvania Consolidated Statutes are amended to read:
- 10 § 2710. [Ethnic] <u>Unlawful</u> intimidation.
- 11 (a) Offense defined. -- A person commits the offense of
- 12 [ethnic] <u>unlawful</u> intimidation if, with malicious intention
- 13 toward the actual or perceived race, color, religion [or],
- 14 national origin, ancestry, mental or physical disability, sexual
- 15 orientation, gender or gender identity of another individual or
- 16 group of individuals, he commits an offense under any other
- 17 provision of this article or under Chapter 33 (relating to
- 18 arson, criminal mischief and other property destruction)
- 19 exclusive of section 3307 (relating to institutional vandalism)

- 1 or under section 3503 (relating to criminal trespass) with
- 2 respect to such individual or his or her property or with
- 3 respect to one or more members of such group or to their
- 4 property.
- 5 * * *
- 6 (c) Definition.--As used in this section "malicious
- 7 intention" means the intention to commit any act, the commission
- 8 of which is a necessary element of any offense referred to in
- 9 subsection (a) motivated by hatred toward the <u>actual or</u>
- 10 perceived race, color, religion [or], national origin, ancestry,
- 11 mental or physical disability, sexual orientation, gender or
- 12 gender identity of another individual or group of individuals.
- 13 Section 2. Section 8309(a) of Title 42 is amended to read:
- 14 § 8309. Civil rights violations.
- 15 (a) Redress for personal injury. -- A person who incurs injury
- 16 to his person or damage or loss to his property as a result of
- 17 conduct described in 18 Pa.C.S. § 2710 (relating to [ethnic]
- 18 <u>unlawful</u> intimidation) or 3307 (relating to institutional
- 19 vandalism) shall have a right of action against the actor for
- 20 injunction, damages or other appropriate civil or equitable
- 21 relief. In the action, the issue of whether the defendant
- 22 engaged in the conduct alleged shall be determined according to
- 23 the burden of proof used in other civil actions for similar
- 24 relief. The plaintiff may seek recovery for any of the
- 25 following:
- 26 (1) General and special damages, including damages for
- emotional distress. Damages under this paragraph shall be
- actual damages or \$500, whichever is greater.
- 29 (2) Punitive damages.
- 30 (3) Reasonable attorney fees and costs.

- 1 (4) Injunctive and other equitable relief.
- 2 (5) Such other relief which the court deems necessary
- 3 and proper.

- 5 Section 3. This act shall take effect in 60 days.
