shall be ex-officio a member of each subcommittee that may be

- 8 attend meetings of the subcommittee and vote on any matter-
- 9 before the subcommittee.
- 10 (b) Calling committee to order. The Chair or, if authorized
- 11 by the Chair, the Vice Chair, shall call the committee to order
- 12 at the hour provided by these Rules. Upon the appearance of a
- 13 quorum, the committee shall proceed with the order of business.
- 14 Any member of the committee may question the existence of a
- 15 quorum.

- 16 (c) Chair control of the committee room. The Chair or, if
- 17 authorized by the Chair, the Vice Chair, shall preserve order
- 18 and decorum and shall have general control of the committee
- 19 room. In case of a disturbance or disorderly conduct in the
- 20 committee room, the Chair or, if authorized by the Chair, the
- 21 Vice Chair, may cause the same to be cleared. The use of cell-
- 22 phones and similar portable communication devices within any
- 23 Senate committee room by individuals other than members of the
- 24 Senate or their staffs is strictly prohibited.
- 25 (d) Chair's authority to sign documents and decide questions
- 26 of order. The Chair shall sign all notices, vouchers, subpoenas
- 27 or reports required or permitted by these Rules. The Chair shall-
- 28 decide all questions of order relative to parliamentary
- 29 procedure, subject to an appeal by any member of the committee.
- 30 (e) Vote of Chair, Vice Chair. The Chair and Vice Chair

- 1 shall vote on all matters before such committee; Provided, That
- 2 the name of the Chair shall be called last.
- 3 (f) Performance of duties by Vice Chair. Upon the death of
- 4 the Chair, the Vice Chair shall perform the duties of the office
- 5 until and unless the President Pro Tempore shall appoint a
- 6 successor. Upon and during disability, or incapacity of the
- 7 Chair, the Vice Chair shall perform the Chair's duties.
- 8 (g) Chair's duty to report. The Chair shall report any bill
- 9 to the Floor of the Senate not later than the next occurring
- 10 legislative day after the committee's vote to report it.
- 11 (h) Amendments. Upon reporting the bill from committee, the
- 12 Chair shall submit all amendments adopted in committee to the
- 13 Secretary-Parliamentarian of the Senate for posting on the-
- 14 Internet website maintained by the Senate.
- 15 Rule 29. Resolutions.
- 16 (a) Introduction. -- All resolutions, Senate and concurrent,
- 17 shall be introduced by presenting five copies of the Resolution,
- 18 with the sponsor identified, to the presiding officer.
- 19 (b) Consideration. -- The following resolutions, after being
- 20 read, shall be referred to an appropriate committee without
- 21 debate unless by unanimous consent the Senate shall otherwise
- 22 direct and, if favorably reported by the committee, shall lie
- 23 over one day for consideration, after which the resolutions may
- 24 be called up under the appropriate order of business:
- 25 (1) All Senate concurrent resolutions and House
- 26 concurrent resolutions, excepting resolutions in reference to
- 27 adjournment sine die, recesses and resolutions recalling
- 28 bills from the Governor, which shall be regarded as
- 29 privileged.
- 30 (2) Resolutions containing calls for information from

- 1 the heads of departments or to alter the Rules.
- 2 (3) Resolutions giving rise to debate, except those that
- 3 relate to the disposition of matters immediately before the
- 4 Senate, those that relate to the business of the day on which
- 5 they were offered, and those that relate to adjournment sine
- 6 die or a recess.
- 7 (c) Printing in Senate History.--
- 8 (1) [Congratulatory resolutions and condolence
- 9 resolutions shall be given to the Secretary-Parliamentarian
- and shall be considered under the order of unfinished
- business in the daily order of business.] (Reserved).
- 12 (2) All resolutions shall be adopted by a majority vote
- of the Senators present except as specifically provided for
- in these Rules.
- 15 (d) Joint Resolutions.--
- 16 (1) Joint resolutions shall be limited to constitutional
- amendments and shall be adopted by a vote of a majority of
- 18 the Senators elected to the Senate.
- 19 (2) A Joint resolution when passed by both Houses shall
- 20 not be transmitted to the Governor for approval or
- 21 disapproval but shall be filed in the Office of the Secretary
- of the Commonwealth in accordance with Article XI, section 1
- of the Constitution of Pennsylvania.
- 24 FURTHER RESOLVED, That the Rules be amended by adding a rule
- 25 to read:
- 26 Rule 29.1. Citations.
- 27 <u>(a) Preparation.--A member making a request that a Senate</u>
- 28 Citation be issued to a particular person or on a specified
- 29 <u>occasion shall provide the Legislative Reference Bureau with the</u>
- 30 facts necessary for the preparation of the citation on a

- 1 <u>suitable form</u>.
- 2 (b) Filing. -- The citation request shall be filed with the
- 3 <u>Secretary-Parliamentarian of the Senate and automatically</u>
- 4 referred to the President Pro Tempore, who may approve and sign
- 5 the citation on behalf of the Senate.
- 6 (c) Issuance. -- One original citation shall be issued by the
- 7 <u>Secretary-Parliamentarian of the Senate.</u>
