A RESOLUTION

- Designating March 11, 2020, as "Registered Dietitian Nutritionist Day" in Pennsylvania.
- 3 WHEREAS, Registered dietitian nutritionists are food and
- 4 nutrition experts who translate the science of nutrition into
- 5 practical solutions for healthy living; and
- 6 WHEREAS, Registered dietitian nutritionists have degrees in
- 7 nutrition, dietetics, public health or a related field from
- 8 well-respected, accredited colleges and universities; and
- 9 WHEREAS, Registered dietitian nutritionists have completed an
- 10 accredited supervised practice program, passed a national
- 11 examination and completed continuing professional education
- 12 requirements to earn the registered dietitian nutritionist
- 13 credential; and
- 14 WHEREAS, Registered dietitian nutritionists form an important
- 15 part of the Academy of Nutrition and Dietetics, which is
- 16 recognizing the month of March 2020 as "National Nutrition
- 17 Month®" and March 11, 2020, as "National Registered Dietitian

- 1 Nutritionist Day"; and
- 2 WHEREAS, The theme for this year's "National Nutrition
- 3 Month®" is "Eat Right, Bite by Bite," which serves as a reminder
- 4 that each one of us holds the tool to make healthier food
- 5 choices; and
- 6 WHEREAS, Pennsylvania licenses many registered dietitian
- 7 nutritionists yearly to work in hospitals, schools, public
- 8 health clinics, nursing homes, fitness centers, the food
- 9 industry, universities and other entities; and
- 10 WHEREAS, Approximately 3,700 residents of this Commonwealth
- 11 are members of the Pennsylvania Academy of Nutrition and
- 12 Dietetics, which is an affiliate of the Academy of Nutrition and
- 13 Dietetics and advocates for promotion of optimal nutrition,
- 14 health and well-being in this Commonwealth; therefore be it
- 15 RESOLVED, That the Senate designate March 11, 2020, as
- 16 "Registered Dietitian Nutritionist Day" in Pennsylvania; and be
- 17 it further
- 18 RESOLVED, That the Senate laud the Pennsylvania Academy of
- 19 Nutrition and Dietetics, all of its members and other registered
- 20 dietitian nutritionists in this Commonwealth for their daily
- 21 work to promote good nutrition, good eating and quality living
- 22 for individuals in this Commonwealth and for their ongoing
- 23 efforts to inform all residents of how to "Eat Right, Bite by
- 24 Bite."
