## A RESOLUTION

1 2	Designating October 20, 2016, as "Lights on Afterschool Day" in Pennsylvania.
3	WHEREAS, More than 28 million children in the United States
4	have parents who work outside the home and more than 15 million
5	children are left unsupervised after the school bell rings; and
6	WHEREAS, Approximately 1.3 million children who are 6 to 17
7	years of age in Pennsylvania have both parents in the work force
8	or, in single-parent families, the sole parent in the work
9	force; and
10	WHEREAS, Eighteen percent of this Commonwealth's school-age
11	children, responsible for taking care of themselves outside
12	school, spend an average of 8.99 hours per week unsupervised
13	after school; and
14	WHEREAS, Out-of-school hours represent the single biggest

14 WHEREAS, Out-of-school hours represent the single biggest 15 block of time for children and youths and are key to the 16 development of children into adolescents and adolescents into 1 adults; and

2 WHEREAS, After school programs provide safe, challenging, 3 engaging and fun learning experiences to help children and 4 youths develop academic, cultural, emotional, physical and 5 social skills; and

6 WHEREAS, After school programs support working families by 7 ensuring that their children are safe and productive during out-8 of-school hours; and

9 WHEREAS, After school programs offer a fun and supportive 10 educational environment for Science, Technology, Engineering and 11 Mathematics (STEM) that helps foster this Commonwealth's 12 economic competitiveness; and

13 WHEREAS, A recent national survey reported that 52% of 14 parents cite cost as a barrier to enrolling their children in 15 after school programs; and

16 WHEREAS, Research illustrates that high-quality programming 17 improves student achievement, reduces crime by and against 18 children and youths and promotes positive social development; 19 and

20 WHEREAS, After school programs build stronger communities by 21 involving parents, business leaders and student and adult 22 volunteers in the lives of our young people, thereby promoting 23 positive relationships among children, youths, families and 24 adults; and

25 WHEREAS, Approximately 811,954 children in Pennsylvania would 26 participate in an after school program if one were available to 27 them; and

28 WHEREAS, Across the country, approximately 19.4 million 29 families report that they would enroll their child in an after 30 school program if one were offered; and
