### RELATING TO TOWNS AND CITIES - CITY HOUSING AUTHORITIES

It is enacted by the General Assembly as follows:

1 SECTION 1. Section 45-25-15 of the General Laws in Chapter 45-25 entitled "City 2 Housing Authorities" is hereby amended to read as follows: 3 45-25-15. Powers of authority enumerated. -- (a) An authority constitutes a public 4 body and a body corporate and politic, exercising public powers, and has all the powers necessary 5 or convenient to carry out and effectuate the purposes and provisions of chapters 25 -- 27 of this title, including the following powers in addition to others granted in this chapter: 6 7 (1) To investigate into living, dwelling, and housing conditions and into the means and 8 methods of improving these conditions; 9 (2) To determine where unsafe, or unsanitary dwelling or housing conditions exist; 10 (3) To study and make recommendations concerning the plan of any city or municipality 11 located within its boundaries in relation to the problem of clearing, replanning, and reconstruction 12 of areas in which unsafe, or unsanitary dwelling or housing conditions exist, and the providing of 13 dwelling accommodations for persons of low income, and to cooperate with any city, municipal 14 or regional planning agency; 15 (4) To prepare, carry out, and operate housing projects; 16 (5) To provide for the construction, reconstruction, improvement, alteration, or repair of 17 any housing project or any part of it;

(6) To take over by purchase, lease, or otherwise, any housing project located within its

boundaries undertaken by any government, or by any city or municipality located in whole or in

- 1 part within its boundaries; 2 (7) To manage as agent of any city or municipality any housing project located in whole 3 or in part within its boundaries; 4 (8) To act as agent for the federal government in connection with the acquisition, 5 construction, operation, and/or management of a housing project or any part of it; (9) To arrange with any city or municipality located in whole or in part within its 6 7 boundaries or with a government for the furnishing, planning, replanning, installing, opening or 8 closing of streets, roads, roadways, alleys, sidewalks, or other places or facilities or for the 9 acquisition by the city, municipality, or, a government of property, options, or property rights, or 10 for the furnishing of property or services in connection with a project; 11 (10) To arrange with the state, its subdivisions and agencies, and any county, city, town, 12 or municipality of the state, to the extent that it is within the scope of each of their respective 13 functions, (i) to cause the services customarily provided by each of them to be rendered for the 14 benefit of the housing authority and/or the occupants of any housing projects, (ii) to provide and 15 maintain parks and sewage, water, and other facilities adjacent to or in connection with housing 16 projects, and (iii) to change the city or municipality map, to plan, replan, zone, or rezone any part 17 of the city or municipality; 18 (11) To lease or rent any of the dwelling or other accommodations or any of the lands, 19 buildings, structures, or facilities embraced in any housing project and to establish and revise the 20 rents or charges for the project; to enter upon any building or property in order to conduct 21 investigations or to make surveys or soundings; 22 (12) To purchase, lease, obtain options upon, acquire by gift, grant, bequest, devise, or 23 otherwise any property real or personal or any interest therein from any person, firm, corporation, 24 city, municipality, or government; 25 (13) To acquire any real property, including improvements and fixtures to this property; 26 to sell, exchange, transfer, assign, or pledge any property real or personal or any interest to this 27 property to any person, firm, corporation, municipality, city, or government; 28 (14) To own, hold, clear, and improve property; 29 (15) To insure or provide for the insurance of the property or operations of the authority 30 against risks as the authority may deem advisable;
  - (16) To procure insurance or guaranties from the federal government of the payment of any debts or parts of debts secured by mortgages made or held by the authority on any property included in any housing project;
- 34 (17) To borrow money upon its bonds, notes, debentures, or other evidences of

1	indebtedness, and to secure them by pledges of its revenues, and (subject to the limitations
2	imposed by this section) by mortgages upon property held or to be held by it, or in any other
3	manner;
4	(18) In connection with any loan, to agree to limitations upon its right to dispose of any
5	housing project or part of a project or to undertake additional housing projects;
6	(19) In connection with any loan by a government, to agree to limitations upon the
7	exercise of any powers conferred upon the authority by this chapter;
8	(20) To invest any funds held in reserves or sinking funds, or any funds not required for
9	immediate disbursements, in property or securities in which savings banks may legally invest
10	funds subject to their control; to sue and be sued;
11	(21) To have a seal and to alter that seal at pleasure; to have perpetual succession;
12	(22) To make and execute contracts and other instruments necessary or convenient to the
13	exercise of the powers of the authority;
14	(23) To make and, from time to time, amend and repeal bylaws, rules, and regulations
15	not inconsistent with this chapter, and to carry into effect the powers and purposes of the
16	authority;
17	(24) To conduct examinations and investigations, and to hear testimony and take proof
18	under oath at public or private hearings on any matter material for its information;
19	(25) To issue subpoenas requiring the attendance of witnesses or the production of books
20	and papers and to issue commissions for the examination of witnesses who are out of the state or
21	unable to attend before the authority, or excused from attendance; and
22	(26) To make available to those agencies, boards or commissions as are charged with the
23	duty of abating or requiring the correction of nuisances or like conditions, or of demolishing
24	unsafe or unsanitary structures within its territorial limits, its findings and recommendations with
25	regard to any building or property where conditions exist which are dangerous to the public
26	health, morals, safety, or welfare.
27	(27) To request and receive from the various state and federal departments and agencies
28	income information relating to unemployment compensation, child support, alimony,
29	supplemental nutritional assistance and public welfare payments to be held in strict
30	confidentiality by the authority and shared as part of the process established with the federal
31	department of housing and urban development's earned income information system in
32	cooperation with other federal and state agencies for the purpose of determining the current
33	income of any applicant regarding rental calculations.
34	(b) Any of the investigations or examinations provided for in this chapter may be

conducted by the authority or by a committee appointed by it, consisting of one or more commissioners, or by counsel, or by an officer or employee specially authorized by the authority, to conduct it. Any commissioner, counsel for the authority, or any person designated by it to conduct an investigation or examination has power to administer oaths, take affidavits, and issue subpoenas or commissions. An authority may exercise any or all the powers conferred upon it, either generally or with respect to any specific housing project or projects, through or by an agent or agents which it may designate, including any corporation or corporations which are or shall be formed under the laws of this state, and, for these purposes, an authority may cause one or more corporations to be formed under the laws of this state or may acquire the capital stock of any corporation or corporations. Any corporate agent, all of the stock of which is owned by the authority or its nominee or nominees, may, to the extent permitted by law exercise any of the powers conferred upon the authority. In addition to all of the other powers conferred upon it, an authority may do all things necessary and convenient to carry out the powers expressly given in chapters 25 and 27 of this title. No provisions with respect to the acquisition, operation, or disposition of property by other public bodies are applicable to an authority unless stated specifically by the legislature.

SECTION 2. This act shall take effect on July 1, 2015.
