RELATING TO HEALTH AND SAFETY -- HAZARDOUS WASTE MANAGEMENT

It is enacted by the General Assembly as follows:

1 SECTION 1. Section 23-19.1-6 of the General Laws in Chapter 23-19.1 entitled
2 "Hazardous Waste Management" is hereby amended to read as follows:

3 **23-19.1-6. Powers and duties of the director.**

4 (a) The director shall adopt any plans, rules, regulations, procedures, and standards as may
5 be necessary to ensure proper, adequate, and sound hazardous waste management and to protect
6 the health and safety of the public, and the environment from the effects of improper hazardous
7 waste management. The plans, rules, regulations, procedures, and standards shall be developed by
8 the director with input and review by the affected persons and agencies including the statewide
9 planning program, the health department, and representative of the generator, transport, and
10 disposal industry as well as an environmental representative. The rules, regulations, procedures,
11 and standards as adopted by the director shall, to the maximum extent practical, be compatible with
12 the rules, regulations, procedures, and standards promulgated by the U.S. environmental protection
13 agency pursuant to §§ 3001-3006 of the Federal Resource Conservation and Recovery Act of 1976,
14 42 U.S.C. § 6901 et seq.; provided, however, no plan, rule, regulation, procedure, or standard
15 promulgated by the director pursuant to this section, shall require the remediation of occurring
16 arsenic in soil, consistent with direct exposure of less than or equal to twenty (20) milligrams per
17 kilogram.

18 (b) The director is authorized to exercise all powers, direct and incidental, necessary to
19 carry out the purposes of this chapter, assure that the state complies with any federal hazardous

1 waste management act and retains maximum control under it, and receives all desired federal
2 grants, aid, and other benefits.

3 SECTION 2. This act shall take effect upon passage.
