Introduced by: The Committee on Health and Human Services at the request of the South Dakota Board of Nursing Facility Administrators

1 FOR AN ACT ENTITLED, An Act to revise certain statutes and administrative rules regarding
2 licensure of nursing facility administrators and to increase certain fees.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 Section 1. That § 36-28-1 be amended to read as follows:

5 36-28-1. ~~For the purposes of this chapter, the following definitions are hereby established~~

6 Terms used in this chapter mean:

7 (1) "Board₁" ~~means~~ the South Dakota ~~State~~ Board of ~~Examiners~~ for Nursing Facility
8 Administrators_;

9 (2) "Nursing facility₂" ~~means~~ any institution or facility defined as such for licensing
10 purposes under South Dakota law or pursuant to the rules ~~and regulations~~ for nursing
11 facilities and homes for the aged by the State Department of Health, whether
12 proprietary or nonprofit, including, ~~but not limited to~~ nursing facilities owned or
13 administered by the federal or state government or an agency or political subdivision
14 thereof_;



1 (3) "Nursing facility administrator," ~~means~~ a person who administers, manages,
 2 supervises, or is in general administrative charge of a nursing facility ~~or homes,~~
 3 whether ~~such~~ the individual has an ownership interest in such ~~home~~ facility and
 4 whether ~~his~~ the function and duties are shared with one or more individuals;
 5 ~~provided, however, that persons. However, no person~~ serving as a member of a
 6 nursing facility's board of directors ~~shall not qualify as~~ is a nursing facility
 7 administrator unless ~~he~~ the person is also serving in the requisite administration
 8 capacity as here defined; and

9 (4) "Administrator-in-training program," an internship completed under the supervision
 10 of a preceptor that meets the requirements established by the board pursuant to
 11 chapter 1-26.

12 Section 2. That § 36-28-2 be amended to read as follows:

13 36-28-2. ~~The South Dakota State Board for Nursing Facility Administrators consists of~~
 14 ~~eleven~~ board consists of five members. The members of the board shall be appointed by the
 15 Governor and shall include ~~one licensed physician and one registered nurse, neither of whom~~
 16 ~~may be an administrator or an employee of a nursing facility nor have any direct financial~~
 17 ~~interest in nursing facilities; one practicing hospital administrator who is also licensed as a~~
 18 ~~nursing facility administrator; two practicing administrators of proprietary nursing facilities; two~~
 19 ~~practicing administrators of nonprofit nursing facilities; a designee of the secretary of health;~~
 20 ~~a designee of the secretary of social services; and, two members~~ four members who are licensed
 21 nursing facility administrators who are actively practicing in South Dakota and one member of
 22 the general public who are not administrators or employees is not an administrator or employee
 23 of a nursing facility and who have has no direct financial interest in ~~nursing facilities~~ a nursing
 24 facility. The terms of all members are to be three years. No member may serve more than three

1 consecutive full terms. The terms of members begin on October thirty-first of the calendar year
2 in which the Governor appoints the member, unless otherwise designated by the Governor. The
3 appointee's term expires on October thirtieth in the third year of appointment. ~~The designees of~~
4 ~~the health and social services departments shall serve without compensation and reimbursement~~
5 ~~as provided in § 36-28-25, except that their travel expenses shall be paid by their respective~~
6 ~~agencies pursuant to § 3-9-2.~~ The appointment to an unexpired term is not considered a full
7 term.

8 Any member's term ending June 30, 2013, or thereafter is extended to October thirtieth in
9 the year the term is to expire.

10 Section 3. That § 36-28-4 be amended to read as follows:

11 36-28-4. The board shall annually elect from its membership a ~~chairman, vice-chairman~~
12 president, vice president, and secretary-treasurer, and shall adopt rules pursuant to chapter 1-26
13 to govern its proceedings. No officer may serve more than three consecutive one-year terms. The
14 board may, in accordance with chapter 3-6A, employ and fix the compensation and duties of
15 ~~necessary personnel to assist it in the performance of its duties~~ expend funds for administrative,
16 consultant, and other necessary services for the board with the amount of the expenditures to
17 be set by the board.

18 Section 4. That chapter 36-28 be amended by adding thereto a NEW SECTION to read as
19 follows:

20 The board shall meet at least annually. A majority of the members constitute a quorum. A
21 majority vote of those present constitutes a decision of the entire board.

22 Section 5. That chapter 36-28 be amended by adding thereto a NEW SECTION to read as
23 follows:

24 The board, its members, and its agents are immune from personal liability for actions taken

1 in good faith in the discharge of the board's responsibilities, and the state shall hold the board,
2 its members, and its agents harmless from all costs, damages, and attorney fees arising from
3 claims and suits against them with respect to matters to which the immunity applies.

4 Section 6. That § 36-28-7 be amended to read as follows:

5 36-28-7. The ~~Board of Examiners is empowered to commence actions for injunctions for~~
6 ~~violations of this chapter or regulations promulgated hereunder as an alternate to criminal~~
7 ~~proceedings. The commencement of one proceeding by the board constitutes an election board~~
8 may commence an action for an injunction for a violation of this chapter or regulation
9 promulgated pursuant to this chapter.

10 Section 7. That § 36-28-11 be amended to read as follows:

11 36-28-11. The ~~Board of Examiners shall have the power, duty, and responsibility to board~~
12 may develop and apply appropriate techniques, including examination and investigation, for
13 determining whether an individual meets the requirements of § 36-28-10. Examination and
14 re-examination fees are nonrefundable and shall be fixed in rules promulgated by the ~~Board of~~
15 ~~Examiners~~ board pursuant to chapter 1-26 and may not exceed two hundred dollars.

16 Section 8. That § 36-28-12 be amended to read as follows:

17 36-28-12. The board may issue ~~licenses to qualified persons as nursing facility~~
18 ~~administrators, and shall~~ a license to a qualified person and may establish qualification criteria
19 pursuant to chapter 1-26 ~~for such nursing facility administrators. No license shall~~ may be issued
20 to a person as a nursing facility administrator unless the applicant:

- 21 (1) ~~He is~~ Is at least eighteen years of age, of good moral character, and of sound physical
22 and mental health;
- 23 (2) ~~He has~~ Has satisfactorily completed ~~a course of instruction and~~ training prescribed
24 by the board, which ~~course~~ shall, by virtue of its content and administration, present

1 sufficient knowledge of the needs properly to be served by nursing facilities, laws
 2 governing the operation of nursing facilities and the protection of the interests of the
 3 residents therein, and the elements of good nursing facility administration; ~~or he must~~
 4 ~~present evidence satisfactory to the board of sufficient education, training or~~
 5 ~~experience in the foregoing fields to administer, supervise and manage a nursing~~
 6 ~~facility; and~~

7 (3) ~~He has~~ Has passed an examination ~~administered~~ approved by the board designed to
 8 test ~~his~~ the applicant's knowledge and competence regarding the subject matter
 9 referred to in subdivision (2) of this section.

10 Section 9. That § 36-28-13 be amended to read as follows:

11 36-28-13. ~~Pending examination, the~~ The board may issue an emergency permit to practice
 12 as a nursing facility administrator for a period not ~~exceeding~~ to exceed one year to a qualified
 13 person filing a written application ~~for a license~~ with the board. The board ~~shall~~ may adopt rules
 14 pursuant to chapter 1-26 regarding application procedures, renewal procedures, supervision, and
 15 the nonrefundable fee for an emergency permit which may not exceed four hundred dollars.

16 Section 10. That § 36-28-14 be amended to read as follows:

17 36-28-14. The board may issue a nursing facility ~~administrator's license, without~~
 18 ~~examination,~~ administrator license to any person who holds a current license as a nursing facility
 19 administrator or equivalent license from another jurisdiction, if the board finds that the
 20 standards for licensure in such other jurisdiction are at least substantially equivalent ~~of~~ to those
 21 prevailing in this state and that the applicant is otherwise qualified. The board may adopt, by
 22 rules promulgated pursuant to chapter 1-26, minimum requirements for qualification and a
 23 nonrefundable fee for reciprocal licensure which may not exceed five hundred dollars.

24 Section 11. That § 36-28-15 be amended to read as follows:

1 36-28-15. Any person applying to be licensed as a nursing facility administrator shall pay
2 ~~an~~ a nonrefundable initial license fee in an amount set by rule promulgated by the board
3 pursuant to chapter 1-26, which may not exceed ~~one hundred fifty~~ five hundred dollars. The
4 initial license fee shall be prorated to the next biennial renewal date according to rule
5 promulgated by the board pursuant to chapter 1-26.

6 Section 12. That § 36-28-16 be amended to read as follows:

7 36-28-16. The ~~Board of Examiners shall~~ board may license nursing facility administrators
8 in accordance with this chapter and rules ~~issued by it in compliance with~~ promulgated by the
9 board pursuant to chapter 1-26. A nursing facility ~~administrator's~~ administrator license ~~shall is~~
10 ~~not be~~ transferable and ~~shall be~~ is valid until surrendered for cancellation or suspended or

15 Section 13. That § 36-28-17 be repealed.

17 ~~licenses to individuals that it deems are qualified under the provisions of this chapter, and for~~
18 ~~cause, after compliance with chapter 1-26, to revoke or suspend licenses previously issued by~~
19 ~~the board in any case where the individual holding such license is determined substantially to~~
20 ~~have failed to conform to the requirements of such standards.~~

21 Section 14. That § 36-28-18 be amended to read as follows:

22 36-28-18. ~~A~~ Each nursing facility ~~administrator's~~ administrator license expires on December
23 thirty-first ~~biennially~~ of even-numbered years and is renewable biennially thereafter upon
24 application to the board and payment of a ~~biennial license~~ renewal fee set ~~by~~ in rule promulgated

1 by the board pursuant to chapter 1-26. The renewal fee may not exceed ~~one hundred fifty five~~
2 hundred dollars.

12 and fulfilling other ~~experiences~~ requirements as determined by the length of inactive status, as
13 prescribed by the board in rules promulgated pursuant to chapter 1-26.

19 ~~circumstances as would constitute grounds for suspension or revocation of a license.~~

22 ~~and administrators of nursing facilities within the state to improve the standards imposed for the~~
23 ~~licensing of such administrators and the procedures and methods for the enforcement of such~~
24 ~~standards.~~

1 Section 19. That § 36-28-21 be repealed.

2 ~~—36-28-21. The Board of Examiners shall have the power, duty and responsibility to conduct,~~
3 ~~or cause to be conducted, one or more courses of instruction and training sufficient to meet the~~
4 ~~requirements of this chapter, and make provisions for such courses and their accessibility to~~
5 ~~residents of this state unless it finds that there are a sufficient number of courses approved by~~
6 ~~the board conducted by others within this state. In lieu hereof the board may approve courses~~
7 ~~conducted within and without this state as sufficient to meet the educational and training~~
8 ~~requirements of this chapter.~~

9 Section 20. That § 36-28-21.1 be amended to read as follows:

10 36-28-21.1. The Board of Examiners shall board may promulgate rules pursuant to chapter
11 1-26 to establish continuing education requirements for renewal of ~~licenses~~ a license.

12 Section 21. That § 36-28-22 be repealed.

18 36-28-23. The Board of Examiners shall have the power, duty, and responsibility to receive,
19 board may investigate; and take appropriate action with respect to any charge or complaint filed
20 ~~with the board to the effect that any individual licensed as a nursing facility administrator has~~
21 ~~failed to comply with the requirements of this chapter~~ if it comes to the attention of the board
22 that a licensee may have violated a provision of this chapter or a rule promulgated pursuant to
23 this chapter. The board may revoke or suspend a license of any licensee violating any provision
24 of this chapter and any rule promulgated pursuant to this chapter.

20 Section 27. That ARSD 20:49:01:01 be amended to read as follows:

21 20:49:01:01. Definitions. Terms ~~defined in SDCL 36-28-1 have the same meaning when~~
22 ~~used in this article. In addition, terms used in this article mean:~~

23 (1) "Preceptor," a ~~licensed nursing facility administrator~~ licensee who has been licensed for
24 at least four years in South Dakota, has had no revocation or suspension of a license or other

1 action taken as deemed necessary to protect the public, and has been approved by the board to
2 train administrators-in-training;

3 (2) "Administrator-in-training," "~~(AIT)~~," a person who is ~~servicing in~~ employed by or
4 contracting with a licensed nursing facility and working under the supervision of a preceptor ~~and~~

2 reexamination a maximum of three times for each examination upon payment of the applicable

12 ~~education program. Applicants applying for relicensure must have completed an~~
13 ~~administrator-in-training program or practicum within the four years preceding the date of the~~

17 (b) Completion of a practicum in long term healthcare administration from a

22 (4) Three letters of recommendation from professional references not related to the applicant

2 years preceding the date of application; and

8 ~~provided by the board. The applicant must submit letters of recommendation from three~~
9 ~~individuals engaged in either business or a profession. The applicant must attach to the~~
10 ~~application a photocopy or certified copy of the applicant's birth certificate or an equivalent birth~~
11 ~~verification. The applicant must provide a certified transcript of the applicant's education and~~
12 ~~training. The completed application, the accompanying documents described in this section, and~~
13 ~~the payment of nonrefundable fees must be received by the board before the examinations~~
14 ~~required in § 20:49:03:01 and the administrator-in-training program required in subdivision~~

16 Section 37. That ARSD 20:49:04:03 be amended to read as follows:

17 20:49:04:03. Conviction of felony. ~~An applicant for examination for licensure who has been~~
18 ~~convicted of a felony by any court may not take the examination. The board may refuse to issue~~
19 ~~a license if the applicant has been convicted, pled no contest, nolo contendere, pled guilty to,~~
20 ~~or been granted a deferred judgment or suspended imposition of sentence, or had prosecution~~
21 ~~deferred with respect to a felony.~~

22 Section 38. That ARSD 20:49:04:08 be repealed.

23 ~~— 20:49:04:08. Initial license fee. The fee for initial licensure is \$150.~~

24 Section 39. That ARSD 20:49:05:01 be amended to read as follows:

1 20:49:05:01. Emergency permit. To meet the needs of a nursing facility that has a vacancy
2 in the administrator's position, an emergency permit to practice as a nursing facility
3 administrator may be issued to a person for not more than 180 days, subject to the following:

4 (1) A person of authority from the facility with the vacancy ~~requests in writing that an~~
5 ~~emergency permit be issued for their emergency administrator~~ submits an application,
6 accompanied by a nonrefundable emergency permit fee of ~~\$100~~ \$200;

7 (2) The emergency administrator ~~is~~ provides services under the supervision of a ~~certified~~
8 preceptor;

9 (3) The preceptor provides appropriate supervision and is reasonably available to the
10 emergency administrator to provide assistance; and

11 (4) The preceptor observes the emergency administrator at least two days a month in the
12 facility in which the emergency administrator is serving and keeps a written memorandum of
13 what was accomplished or discussed at each visit. ~~This~~ A copy of the dated memorandum shall
14 accompany the monthly report required in subdivision (4) of this section; and

15 ~~—(4) The preceptor makes a written report to the board every month on the performance of~~
16 ~~the emergency administrator~~ be maintained by the emergency administrator and the preceptor
17 for one year following the date of expiration of the emergency permit.

18 A preceptor may be held responsible for the acts of the emergency administrator operating
19 under the preceptor's supervision only if the preceptor does not fulfill the requirements as stated
20 above.
