- 1 FOR AN ACT ENTITLED, An Act to prohibit the use of certain photo radar speed detection
- 2 systems and of certain photo monitoring devices to detect red light violations.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:
- 4 Section 1. That chapter 32-25 be amended by adding thereto a NEW SECTION to read as
- 5 follows:
- No state, county, municipal, or township authority may use photo radar speed detection to
- 7 determine compliance with any speed restriction imposed by this chapter or by any local
- 8 ordinance.
- 9 Section 2. That chapter 32-28 be amended by adding thereto a NEW SECTION to read as
- 10 follows:
- No state, county, municipal, or township authority may use a photo monitoring device to
- detect any red light violation.

Section 3. That chapter 32-25 be amended by adding thereto a NEW SECTION to read as

- 2 follows:
- For the purposes of section 1 of this Act, the term, photo radar speed detection, means the
- 4 detection of a vehicle's speed by use of a radar device combined with photographic
- 5 identification of the vehicle.
- 6 Section 4. That chapter 32-28 be amended by adding thereto a NEW SECTION to read as
- 7 follows:
- 8 For the purposes of section 2 of this Act, the term, photo monitoring device, means a device
- 9 used with a lighted traffic control device to detect a red light violation combined with a
- 10 photographic identification of the vehicle.
- 11 Section 5. That chapter 32-28 be amended by adding thereto a NEW SECTION to read as
- 12 follows:
- This Act constitutes a general law of the state within the meaning of S.D. Const., Article IX,
- 14 § 2.
